Double yellow lines (no parking at any time) at Gun Lane Knebworth

### What is the purpose of the proposal?

To prevent vehicles from parking and obscuring visibility at bend in road by extending the existing double yellow lines.

The second public consultation stage is open to anyone. An advertisement will be placed in the local newspaper. A site notice and plan will also be erected on lamp columns in the locality. It is intended that this will take place during **December / January, 2018**

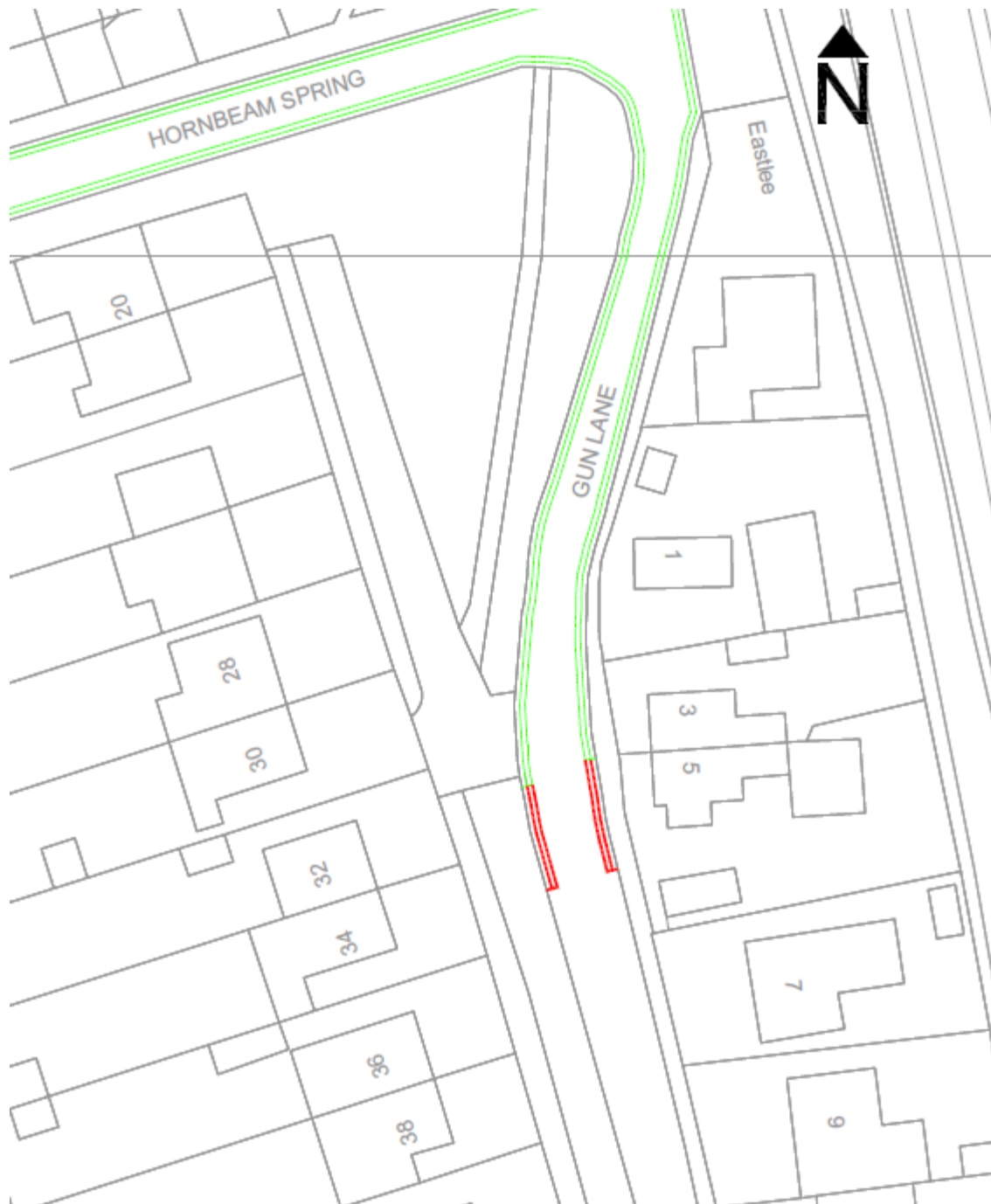
