1. Decision

- 1.1 The Director of Property has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information.
- 1.2 Subject to 1.1 above, awards the contract for the provision of Grounds Maintenance for the sites currently within the Shared Managed Services (SMS) Contract to Frank Cooper and Son Ltd as set out in Annex A and approves the signing of the contract.

2. **Reasons for the decision**

Grounds Maintenance at the majority of HCC operational sites is already delivered via contractors from Herts FullStop's (HFS) Grounds Maintenance framework and managed by HFS on behalf of Property. Removing this service from the current Shared Managed Service contract and managing it in the same way enables Property to have a consistent approach across the operational estate (non-schools).

HFS invited the suppliers on their framework, which was set up under HCCs procurement rules, to submit bids for grounds maintenance at the properties currently within the SMS contract.

Tender submissions were evaluated, and Frank Cooper and Son Ltd bid was calculated as the best based on a price and quality assessment.

This solution will also enable HCC to realise savings, as set out in Appendix A.

In-source the grounds maintenance service to the council and outsource via a separate open procurement.
