1. Decision

- 1.1 That the Director of Improvement and Technology has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information.
- 1.2 Subject to 1.1 above to novate from Orbus the iServer365 SaaS provision, contract to commence from 31st March 2023 until 30th March 2027.

2. Reasons for the decision

The Orbus iServer365 SaaS provision contract will still be required after the Serco contract is terminated so it's important that the contract is Novated over to HCC, in order to continue with the service. The SaaS solution provides a repository process and architecture documentation, as well as a landscape of HCC's software and hardware. This allows us to create maps of our as-is and to-be processes, high level designs of key architecture and links our IT software and hardware through those diagrams; to allow us sight of our IT landscape. It provides a single source of truth of our IT and applications landscape and has been part of HCC's IT and application management toolkit for the past 5 years.

3. Alternative options considered and rejected

Procuring a new contract was considered and rejected due to the fact that the term of the existing contract (ending 30/03/27), was longer than the end of the Serco contract (31/03/23). The current Orbus contract was renewed for five years on 31st March 2022, with a clause to Novate from Serco to HCC with the foresight it would still be required after the Serco contract was terminated.
