Whether or not to allocate £0.450m from the High Needs Provision Capital Allocation to fund feasibility studies across up to nine schools.

2. Reasons for the decision

In December 20201, Cabinet approved the Special School Place Planning Strategy 2020-2023, which was subsequently extended in April 20242. The strategy shows that the need for special school places has risen sharply in recent years and that demand is forecast to continue to exceed supply.

There is a continued need to deliver additional specialist places in Hertfordshire to meet this demand. This aligns with Priority 3 of the Strategy to meet the immediate need for specialist places.

Following a viability assessment, nine school projects have been identified to move to more detailed feasibility. These projects could deliver an additional 223 specialist places by September 2027. Endorsement is therefore sought from the Executive Members for the Director of Finance to approve £0.450m from the existing High Needs Capital Grant Allocation to fund feasibility work for the proposed projects.
