# DECISION RECORD 1

Subject: THE HERTFORDSHIRE (VARIOUS ROADS, WARE) (RESTRICTION OF WAITING) ÖRDER 2016

### 1. Decision:

• To proceed with the implementation of "No waiting at any time" waiting restrictions as advertised or with amendments on parts of Lime Close, High Oak Road, Southall Close, Fanhams Hall Road (including part of the access road leading to Ware Youth FC), Coltsfoot Road and Lady Margaret Gardens.

## 2. Reasons for the decision:

Conquitonal conquitade

 The proposals are to introduce No waiting at any time waiting restrictions following concerns received about the current on-street parking causing reduced forward visibility and obstructing access at various junctions and locations identified.

The proposed schemes were designed to:

- Maintain access and visibility for both pedestrians and vehicular traffic,
- Ensure free flow of traffic and
- Discourage inconsiderate parking.

Residents/businesses that were informally consulted were informed of the consultation results. The schemes were to progress to formal consultation with amendments to Southall Close proposals in order to balance the need for on street parking.

During formal consultation, we received a reply from the Hertfordshire Constabulary (HC) who raised no objection.

There were 8 objections received during the formal stage from Southall Close and 1 objection from Fanhams Hall Road, Coltsfoot Road, & Lady Margaret Gardens. The objectors for Southall Close asked the County Council to consider providing "Residents parking scheme" for the area. The Council cannot consider this as it is a function of EHDC. The objection from Fanhams Hall Road, Coltsfoot Road, & Lady Margaret Gardens was resolved successfully.

The measures are consistent with the Highway Code (clause 243) which states that "Do not stop or park anywhere you would prevent access for Emergency Services, at or near a bus or tram stop or taxi rank, opposite or within 10 metres (32 feet) of a junction, except in an authorised parking space, opposite a traffic island or (if this would cause an obstruction) another parked vehicle, where the kerb has been lowered to help wheelchair users and powered mobility vehicles, in front of an entrance to a property, on a bend, where you would obstruct cyclists' use of cycle facilities except when forced to do so by stationary traffic."

Having fully considered the grounds of the objections for Southall Close, the decision is to overrule the objections and proceed to sealing of the Order as advertised, and as amended on part of Southall Close and Coltsfoot Road.

## 3.1 Alternative options considered and rejected <sup>2</sup>

The only changes made are for Southall Close and Coltsfoot Road where the double yellow lines have been reduced; the rest of the other proposals remain unchanged throughout the process.
