#### 1. Decision

- 1.1 That the Head of SEND Commissioning has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information;
- 1.2 Subject to 1.1 above, awards the contract for the Provision of a Residential Home for Children and Young People Ages 11 18 with Autism, and/or Learning Disabilities with Challenging Behaviour to the preferred supplier set out in Annex A and approves the signing of the contract.

#### 2. Reasons for the decision

A procurement process has been carried out to award a contract for the Provision of a Residential Home for Children and Young People Ages 11 – 18 with Autism, and/or Learning Disabilities with Challenging Behaviour based on the most economically advantageous tender when evaluated against the following criteria:

Price 40% Quality 60%

# 3. Alternative options considered and rejected <sup>2</sup>

The Council issued an Invitation to Tender following a Contract Notice being placed in the OJEU on 15<sup>th</sup> December 2017. Following a number of clarifications raised by bidders, and addressed by the Council, four tenders were submitted by the deadline of Friday 23<sup>rd</sup> February 2018.

Each tender bid was evaluated against a pre-disclosed robust set of evaluation criteria.

The successful tender achieved the highest score when evaluated against the evaluation criteria.
