1. Decision

1.1 That the Director of Children's Services; has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information;

1.2 Subject to 1.1 above, awards the contract for the provision of Family Support element of the Family Centre Service to the preferred suppliers set out in Annex A and approves the signing of the contracts.

2. Reasons for the decision

A procurement process has been carried out to award contracts for the provision of Family Support element of the Family Centre Service based on the most economically advantageous tender when evaluated against the following criteria:

Price	20%
Quality	80%

3. Alternative options considered and rejected ²

The Council issued an Invitation to tender following a Contract Notice being placed in the OJEU and the procurement was split into four (4) separate Lots.

Between two (2) and four (4) tenders were received for each Lot in response to this Invitation to Tender and each was evaluated against a pre-disclosed robust set of evaluation criteria.

The successful tender for each Lot achieved the highest score when evaluated against the evaluation criteria.

The name of the successful tenderer for each Lot is set out in Annex A.
