1. Decision

- 1.1 That the Head of CLA and Safeguarding has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information;

Price 70% Quality 30%

The successful tender achieved the highest score when evaluated against the evaluation criteria.
