#### 3. Reason(s) the decision could not wait until the next meeting of Cabinet

The Secretary of State for Health and Social Care recently announced additional Winter Care Grant for Local Government, and details were confirmed in a letter to authorities on 17 October 2018. The County Council's allocation of this grant is £4,134,415.

The funding is provided to help councils alleviate winter pressures on the NHS, getting patients home quicker and freeing up hospital beds across England. There is an expectation that authorities will deploy the new monies quickly in order to help address pressure on the system. Officers need to agree plans and discuss with Clinical Commissioning Groups in Hertfordshire, and thereafter to begin to spend monies as soon as can be achieved, in advance of the Cabinet meeting on 17 December 2018.

The proposed decision will be in relation to spend anticipated to take place before the meeting of Cabinet in December 2018, to which meeting the decision to spend the balance of monies will be referred.
