1. Decision <sup>2</sup>

To extend the Weston Hills Inspection and Maintenance Services Contract by one year.

2. Reasons for the decision <sup>3</sup>

Maintenance of the mechanical and electrical equipment associated with the Weston Hills Tunnel on the A505 Baldock Bypass will be required for the life of the tunnel. Current contractor is providing an appropriate level of service.

3. Alternative options considered and rejected <sup>4</sup>

Not extending the contract would mean procuring a new service, which is costly and at this time not deemed necessary due to satisfactory service delivery.

Contract allows extensions in 1 or 2 year bites up to a total of 5 years. Potential to extend contract further to be considered in 2019.

Weston Hills – I agree that limiting the extension to 1 year is prudent, to see if we get the service levels observed.
