1. Decision <sup>2</sup>

To extend the Highways Surface Maintenance and Road Treatments (SMART) framework contract by one year.

2. Reasons for the decision <sup>3</sup>

This framework contract is needed to deliver highway maintenance projects in line with HCC's asset management approach.

3. Alternative options considered and rejected <sup>4</sup>

Not extending the contract would mean procuring a new service, which is costly and at this time not deemed necessary due to satisfactory levels of service delivery.
