1. Decision

- 1.1 That Jenny Coles, the Director of Children's Services, has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information;

The Council Issued an Invitation to Tender following a Contract Notice being placed in the OJEU.

Twenty-two tender bids were received in response to this Invitation to Tender and each was evaluated against a pre-disclosed robust set of evaluation criteria.

The twelve successful tenders achieved the highest scores when evaluated against the evaluation criteria.
