SCHOOLS CAPITAL REPAIRS & MAINTENANCE

1. Purpose of the Report

1.1. To provide an update on the County Council's schools capital repairs and maintenance programme and other relevant property matters.

2. Recommendations

- 2.1. Schools Forum is asked to note:
 - Updated progress of the 2018/19 programme (section 4)

3. Background

- 3.1. Over the past six years over 300 projects have been delivered in maintained schools using a capital grant provided by the Education & Skills Funding Agency (ESFA) for addressing condition. This has resulted in significant building fabric improvements across all types of maintained schools and is overseen by the County Council's Building Management Team.
- 3.2. The centrally managed programme has been tendered as discrete batches of work via the County Council's Property Frameworks (Appendix 1).

4. Update on delivery of 2018/19 R&M programme

4.1. The updated table below provides a summary of the programme agreed by Forum in January 2018 and amendments agreed in July 2018. A detailed list of schemes was included in previous papers.

Update on batches

- 4.2. The Forum's continued support for undertaking feasibility early has enabled work to progress well across all batches. 30 schemes are already in the construction phase and £7.5m of actual expenditure has been delivered as at the end of quarter 2. There is currently a minor risk of overspending the budget as a consequence of over-programming and delivery. The programme is currently carrying the unforeseen costs of the works at Highwood school which are subject to legal claim and may be recovered.
- 4.3. Despite an increased emphasis on heating systems within the programme a number of schools are already flagging concerns ahead of the winter which represents a further risk to the programme. Capital funding has been used to purchase temporary boilers that are being deployed on sites until it is possible to mobilise schemes. We are providing support wherever possible and urge schools to submit bids in plenty of time to address concerns.
- 4.4. Should significant unforeseen need arise some 'work in progress' may have to be delayed. A formal decision to delay or re-programme budget from 2019/20 will be made at the end of Quarter 3. Any unforeseen elements in excess of the planned 2018/19 programme will have first call on the 2019/20 allocation. It is suggested that the uncommitted contingency is left until the spring.

5. Draft 2019/20 programme

5.1. A further round of bid consideration was held in October 2018. This reviewed schemes worth an estimated £19m for potential inclusion in the 2019/20 programme. Whilst the exact amount of grant is unknown the County Council's budget has included £17.579 for planning purposes. This figure is likely to be less, accounting for schools converting during the 2018/19 year and therefore a prudent approach to programming has been adopted.

5.2. New schemes with an estimated value of £13m are therefore being recommended for inclusion in the 2019/20 programme. These are summarised below and listed in full in Appendix 2. This approach provides sufficient contingency for unknown costs and unplanned urgent works that might arise in the interim period and allows for any reduction in grant.

5.3. The programme demonstrates continued focus on core fabric with a shift from roofing towards mechanical (heating and water distribution). Consistent with previous years we are taking a whole system approach to mechanical and electrical schemes. This is reflected in the above programme although this is not always the case in bids from schools.

Small schools

- 5.4. An allocation of £600k is being recommended to support bids from small schools for lower value capital works that traditionally would not be supported. This scheme is being promoted to provide financial support where required to works that fall between the £3k and £15k price band. The definition of small schools is being defined as those with fewer than 160 pupils. A list of eligible schools is attached (Appendix 3).
- 5.5. As the funding available through HCC is only accessible to community schools dialogue has taken place with the St Albans Diocese to ensure that small church schools are not disadvantaged. This has concluded that the diocese already has in place contingency to support these schools. Applications for funding will therefore be handled in the normal way. The fund is based on a nominal £15k per school although funding is not guaranteed and any unallocated will be rolled back in to the main programme.

Contingency

5.6. The contingency is currently held to account for cost increases on the 18/19 programme currently being quantified. An amount of up to £2m should remain protected should it be necessary to re-programme this

- funding rather than defer work which needs to be done this will include early works where required on schemes within the 19/20 programme.
- 5.7. A further £1m is held within contingency for works to the special school portfolio pending the outcomes of the SEN review. These works can no longer be deferred beyond 19/20 but have yet to be committed.

6. Future years

- 6.1. Work is progressing on the basis that some form of grant will continue to be made available for addressing school condition beyond 2020. Despite continuing emphasis on a commitment to quality school buildings the Government has however not made any announcements beyond 2018/19.
- 6.2. The ESFA is conducting another round of school condition surveys which is expected to inform future funding beyond 2021. It is reasonable to expect the grant to continue but for it to be adjusted downward as more schools convert to academy status.
- 6.3. No new funding will be awarded to schools who have indicated their intention to convert. Previous firm commitments made to schools who are converting will however continue to be honoured.
- 6.4. Currently schemes valued at £7.8m remain unfunded and have been deferred for a future years programme. Details are included within Appendix 4.
- 6.5. The rationale previously agreed with the Schools Forum continues to be applied to all new bids for funding. The process and timetable is published on the GRID. Further rounds of bid consideration will be undertaken in the autumn and spring. Only exceptional or emergency works will be funded in year.
- 6.6. Schools whose schemes remain unfunded will continue to have to manage the day-to-day problems arising from the poor condition of their buildings. A number of these schools have already been deferred from previous years.
- 6.7. Schools have been advised to report any significant deterioration in condition so that this can be considered alongside the original bid. Support will be offered to support emergency works wherever funding is available to do so. However, schools cannot rely on this route for funding and must continue to demonstrate that sufficient management and maintenance is in place to effectively avoid the emergency arising.
- 6.8. The overall distribution of funds to date has reflected need rather than any formal allocation to sector or geography. The majority has gone into the primary sector although a number of large schemes have been supported in maintained secondaries. As more of these schools convert it is likely that a greater proportion will return to the primary sector.

7. Healthy Pupils Capital Grant

- 7.1. The window for submitting applications for the c. £1m Healthy Pupils funding remains open until the end of November. The panel will meet in December to make recommendations about funding.
- 7.2. As at 1st November 16 bids had been received amounting to £980k ranging from £5k to £500k. These are included in Appendix 5. A number of additional schemes have already been rejected as not suitable for capital funding however the majority satisfied the criteria and are to be taken forward to the panel for consideration. Applications have been received from schools in target areas where the data identifies greatest health inequality.
- 7.3. At the current level of interest it should be possible to support nearly all the schemes that have been put forward.

8. Other Property Matters

- 8.1. Advice and support for schools The information available to schools on the GRID has been refreshed and enhanced with new FAQs and Top 10 Tips to support self-help. The Property team continues to manage over 50 enquiries per month from schools about property related matters.
- 8.2. Condition Data Collection survey The ESFA is continuing to undertake schools property condition surveys. They are hoping to have completed this programme by September 2019 along with the provision of dashboards to enable responsible bodies to analyse the data. Individual reports are being sent to schools when they become available. The ESFA currently has a significant backlog.
- 8.3. Asbestos Management Assurance Process The ESFA has convened a national working group to respond to the asbestos survey they undertook and in response to renewed ministerial pressure to address the issue of asbestos in schools. HCC is currently responding to a request from the ESFA to provide assurances in relation to asbestos management for all schools that did not respond to the survey.
- 8.4. Programme Performance the Property team are working on a revised set of performance measures, feedback and systems to further improve the rigour applied to the programme which should enable improved quality of reporting for 2019/20.

9. Summary

9.1. The schools repairs and maintenance programme continues to be successful at delivering a large volume of work across the schools estate. A further £18m of improvements was delivered during 2017/18 and is on

- track for delivery in 2018/19.
- 9.2. The future of the programme is dependent on ESFA funding being available beyond 2018/19. This is currently not known.
- 9.3. Although reduced, there remain a large number of schools in need of condition related improvements whose proposed schemes are unfunded. They will continue to have to manage the interim challenges within increasingly difficult financial circumstances.
- 9.4. Further support will now be given to support small schools through the programme.

Appendix 1: Summary of schools R&M Batches

Phase 1 - 3: HCC batches 1-11 (158 schools), managed by consultants Artelia, Atkins and Ingleton Wood are all now complete.

Phase 4: HCC Batches 12-16 (31 schools) managed by consultants Ingleton Wood, Pick Everard and Artelia are complete.

Phase 5: HCC Batches 17-20 (31 schools) managed by Ingleton Wood. The majority of schemes are now complete.

Phase 6: HCC Batches 21-23 (24 schools) were tendered in the autumn of 2014 and awarded to consultants Artelia and NPS. All schemes are complete.

Phase 7: HCC Batch 24 (34 schools) is being managed by Ingleton Wood. All works are now complete.

Phase 8: HCC Batches 25-29 (16 schools) are being managed by Mouchel (Kier), Capital, Mouchel (Kier), Artelia and Pellings respectively. All schemes are complete.

Phase 9: HCC Batches 30-32 (28 schools) are complete.

Phase 10: HCC Batches 33-39 (40 schools) are being managed by Ingleton Wood, NPS and Pellings. The majority are now in retention.

Phase 11: HCC Batches 40-42 (37 schools) are being managed directly by BMT with support from consultants providing cost and quality assurance. Contractors have been appointed and most schemes are under construction.

Phase 12: HCC Batches 43-45 (21 schools) currently under design and early stage feasibility.
