Building Futures Awards 2015



The 'Building Futures Awards 2015' are approaching and provide a fantastic opportunity to promote the leaders of sustainable design in Hertfordshire.

The awards recognise and reward projects that demonstrate sustainability, innovation and high quality design in response to environmental challenges. Projects must be located in Hertfordshire, and have been constructed since 16th September 2013. They can

be entered under one or more award categories that include the most sustainable construction, design excellence, climate change adaptation, and retrofit for the future.

Housing Standards Review

The Government has announced the conclusion to the Housing Standards Review. The review aimed to cut red tape for house builders, and simplify government regulations and standards into one key set, driven by Building Regulations.

As well as the amendments to the current regulations, there will be new dual level Building Regulations for access and water giving local authorities the choice to require developers to build to different standards than the minimum requirements. Local Authorities can also use the new space standards which make up the new national technical standards. There will also be a new mandatory security regulation.

The Government has also clarified the future of the Code for Sustainable Homes. In England the code has been revoked for all but 'legacy' developments. Legacy developments are legally contracted to apply the code such as affordable housing funded through the National Housing Programme. Another example is where a project has already been granted planning permission subject to a code rating.
