Comments from the Appointing Authority

The LAF have had a busy and productive year with lots of useful advice given to the Authority on a whole host of access issues, both strategic and local, as they have arisen in the county. The membership turnover has been successfully replaced and it is a very positive sign that we have had good applicants and been able to appoint.

We look forward to continuing our positive relationship with the LAF and working with the members to improve the access network across Herts.

Comments from LAF Chair

This past year has been an incredibly difficult year, when we were threatened with the outsourcing of the RoW & CMS Services in Herts. and the LAF lost its dedicated admin hours.

Our Vice-Chair and several new members have been recruited which has refreshed the group and added new aspects to our work.

We are now involved in a large number of local organisations and groups which are seeking support and input from LAF members and eager to work with the LAF on access issues, but this is not reflected in being able to work with either the LEP or the LNP in Herts, who seem to have other agendas.

The LAF in Herts. is seen and supported by the public as a body which is worth joining and the public awareness of the LAF seems to have grown. We continue to welcome new members and it is pleasing that we are able to recruit.

Once again thanks to the RoW team and the LAF members for their time over the past year.

Any other comments

We would welcome more certainty from NE on its contribution to LAFs and a single national LAF meeting (rather than the 2 split).

² The Countryside and Rights of Way Act, 2000, Section 94(4) specifies that it is the function of a local access forum, as respects to the area for which it is established, to advise the appointing authority; the local highway authority; other bodies exercising functions under CROW Act Part 1 (Natural England, Forestry Commission and English Heritage) and such other bodies as may be prescribed. These other bodies are set out in the LAF Regulations 2007, paragraph 21, and include: any conservation board established by the Secretary of State, any parish or town council in the area covered by the LAF, and Sport England.
