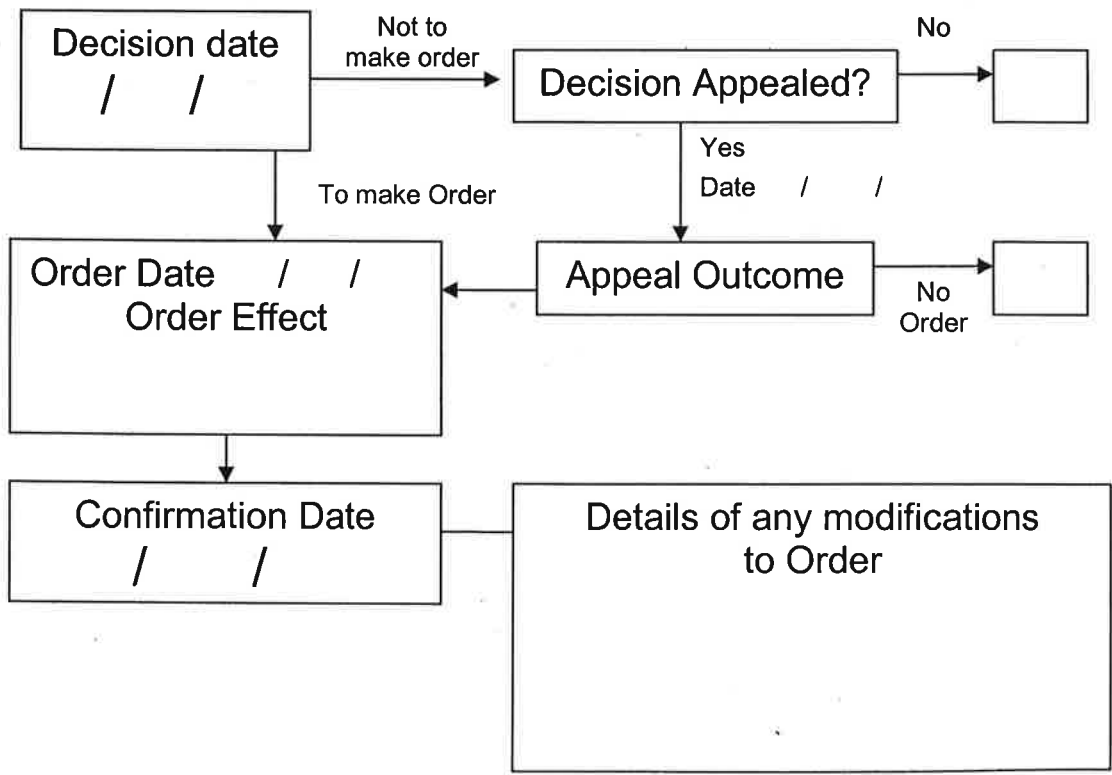

I, Mark Harold Westley, of Little Hollies, 38 Shephall Green, STEVENAGE SG2 9XS hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by

- A. adding the byway open to all traffic from TL305287 (Cromer Mill) northwards to FP49 (Ardeley)
  - B. adding the byway open to all traffic from TL318270 northwards to Gardners Green
  - C. adding the byway open to all traffic from TL333241 northwards to Sander's Green
  - D. adding the bridleway from TL303275 (S of Bury Grange) via Markham's Wood to TL307278
  - E. adding the bridleway from TL317280 (W of Drinkwater Wood) via Gardners to Honey Lane
  - F. adding the bridleway from TL319271 (on BOAT B to Gardners Green) eastwards to BOAT24
  - G. adding the bridleway from TL328256 southeastwards to Coates Manor Farm
  - H. adding the bridleway from TL328249 (Lye Lane) via Little Lye Grove to Sander's Green
  - I. adding the bridleway from TL333246 northwards along the Old Bourne to BOAT10 (Back Lane)
  - J. adding the footpath from TL314264 (FP14) northwards to TL313267 (FP15)
  - K. adding the footpath from TL319258 (BOAT4) northwards to TL319263 (Muncher's Green)
  - L. upgrading to byway open to all traffic that part of FP49 (Ardeley) to the NW of Cromer Mill
  - M. upgrading to bridleway FP38 (Ardeley) from RUPP16 (Walkern) to BOAT39 (Ardeley)

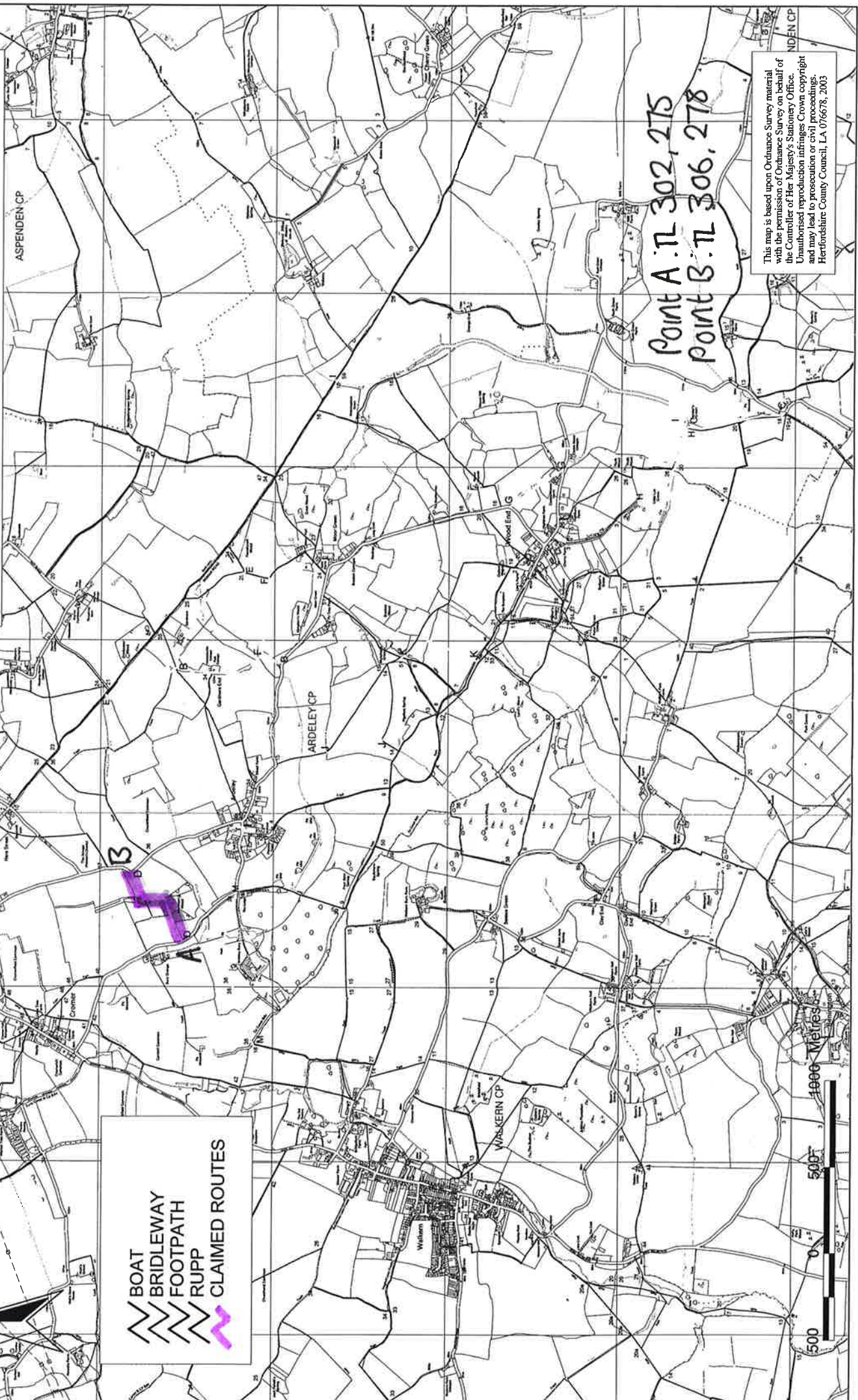
