

RESTRICTED BYWAY DIVERSION

The landowners have applied to Hertfordshire County Council for the diversion of parts of Restricted Byway 10 Barkway, which runs across their property. The change is shown on the attached plan. You are at point 'A' on the plan.

The proposed route is currently available for public use, but as a permissive route. The diversion will give the public a right to use the proposed route and ensure its future availability. The standard to which the route is maintained will be improved and cutting will be carried out before the change takes place.

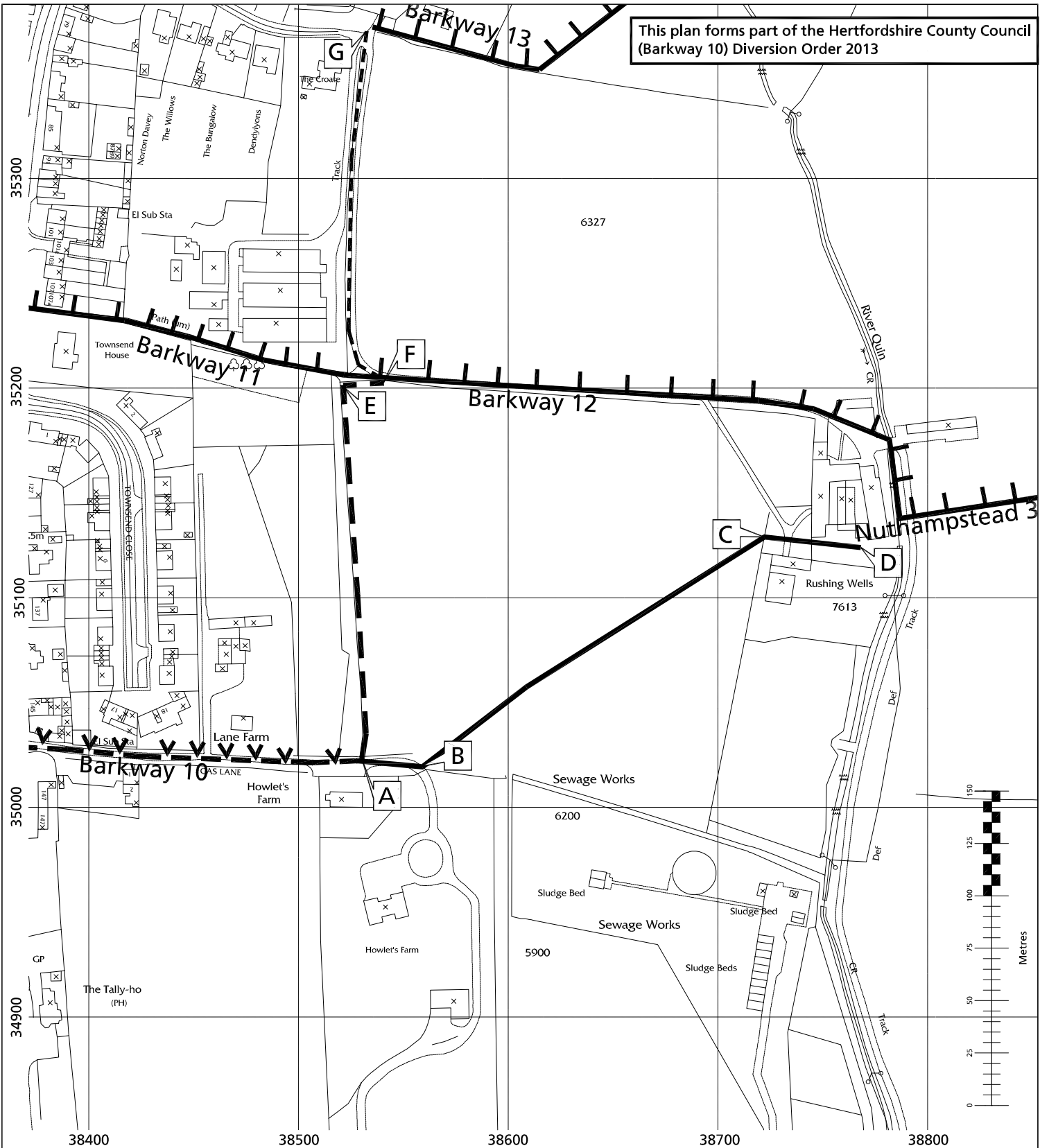

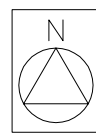
