

## FOOTPATH DIVERSION

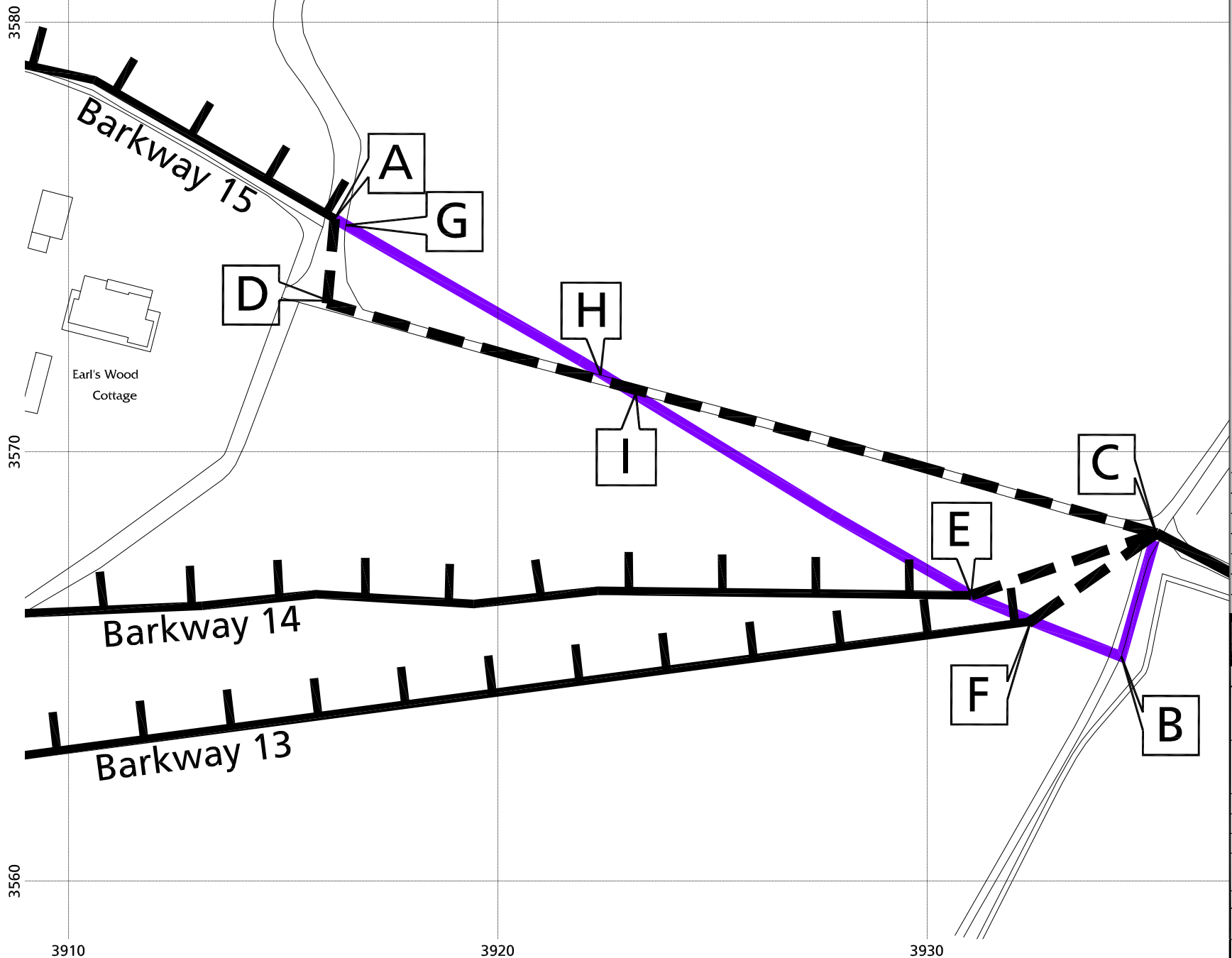
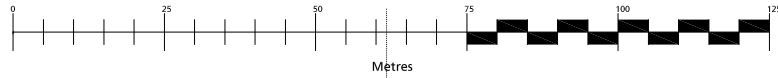

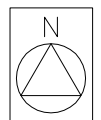
