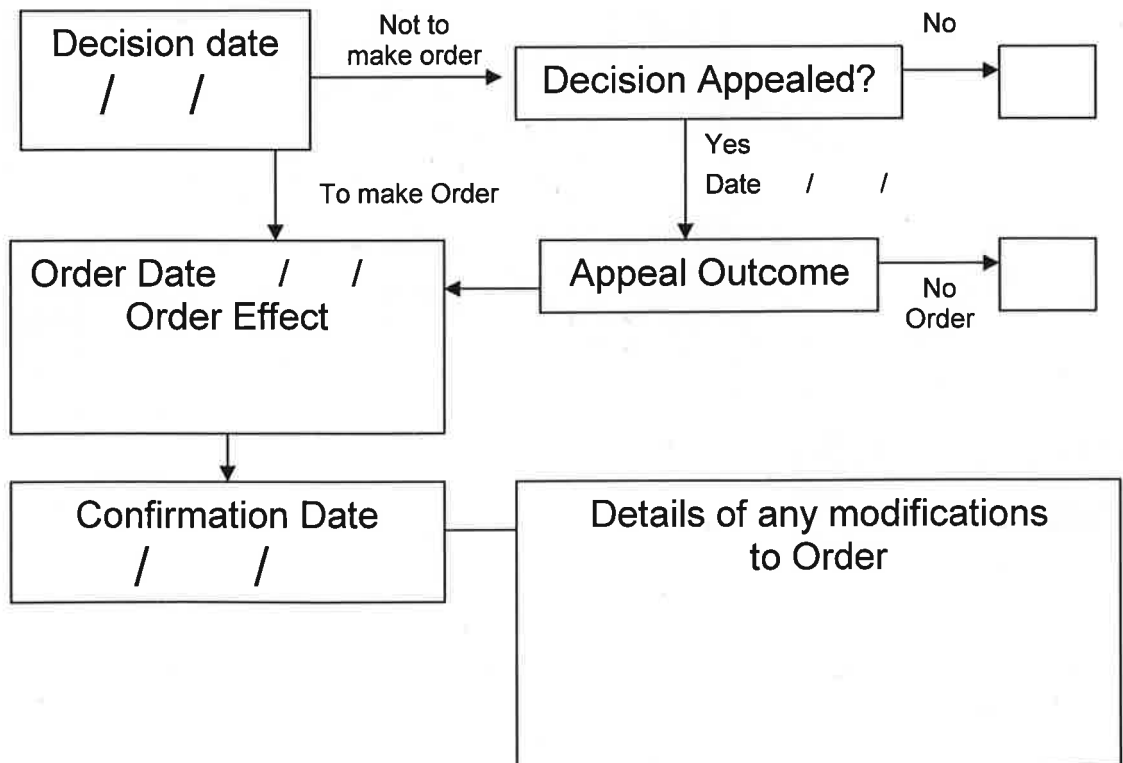

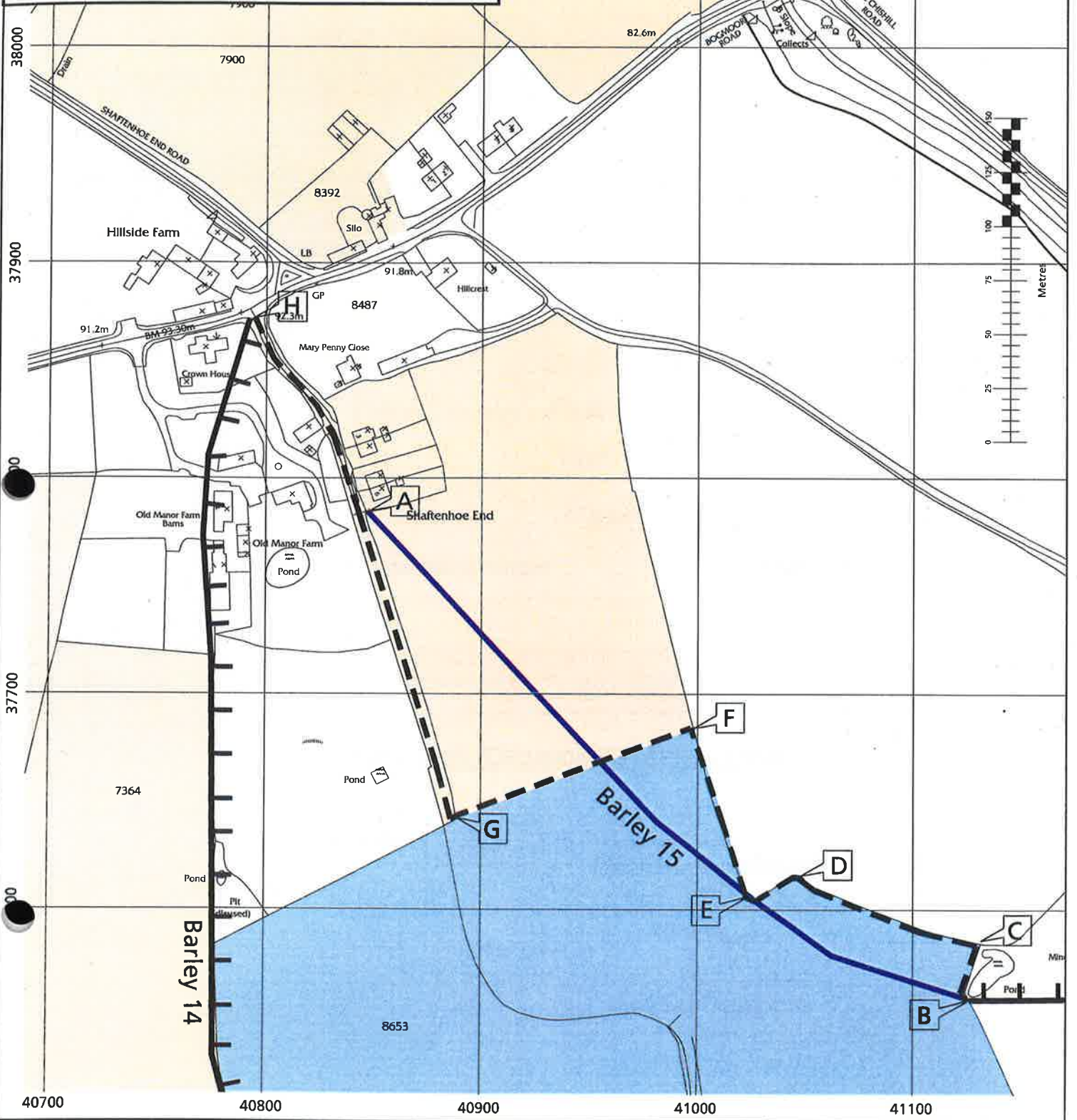

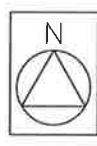


This plan forms part of the Hertfordshire County Council (Barley 15) Diversion Order 2012
