

NOTICE OF CONFIRMATION OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

HERTFORDSHIRE COUNTY COUNCIL

Definitive Map and Statement of Public Rights of Way in Hertfordshire

Hertfordshire County Council (Bishop's Stortford 86) Modification Order 2014

The above order, made on 22nd August 2014, was confirmed without modification on 31st October 2014.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding to them a Footpath commencing from Bryan Road (Public Highway) at TL 4876 2179 running east north-east for approximately 50 metres to TL 4881 2180.

A copy of the order and the order plan may be seen free of charge at front reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday, and East Herts District Council, Wallfields, Hertford, Hertfordshire SG13 8EQ. Copies of the order and plan may be bought at the price of £2.

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 13th November 2014, make application for the purpose of the High Court.

The Definitive Map and Statement of Public Rights of Way in Hertfordshire

Hertfordshire County Council (Bishop's Stortford 86) Modification Order 2014

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date shall be 1st August 2014.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Bishop's Stortford 86) Modification Order 2014.
