OF MODIFICATION ORDER

**The Hertfordshire County Council (Bishop's Stortford 85)
Modification Order 2009**

The above named Order, made on 3rd April 2009, was confirmed without modifications by an Inspector acting for the Secretary of State for the Environment on 22nd May 2009.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding the footpath running from Manor Road at TL 4948 2134 (point A on the Order Plan) and continuing along the school driveway in an easterly direction for approximately 30 metres to meet Bishop's Stortford Footpath 53 at TL 4950 2133 (point B on the Order Plan).

A copy of the confirmed Order may be seen free of charge at Front Reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and can be bought from Hertfordshire County Council at a cost of £2. A copy of the confirmed Order and Notice may also be seen at East Herts Council, Wallfields, Hertford.

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 12th June 2014, make application for the purpose of the High Court.

WILDLIFE AND COUNTRYSIDE ACT 1981

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority have consulted with every local authority whose area includes land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date shall be 20th February 2009
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Bishop's Stortford 85) Modification Order 2009.

DESCRIPTION OF PATH TO BE ADDED


A footpath commencing at Manor Road at point A on the Order Plan (TL 4948 2134) and continuing along the school driveway in an easterly direction for approximately 30 metres to meet Bishop's Stortford Footpath 53 at point B on the Order Plan (TL 4950 2133).

Width: Varying from 10 metres to 3.5 metres between points A and B as shown shaded grey on the Order Plan


