

NOTICE OF CONFIRMATION OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

HERTFORDSHIRE COUNTY COUNCIL

Definitive Map and Statement of Public Rights of Way in Hertfordshire

**Hertfordshire County Council
(Cheshunt 82) Modification Order 2015**

The above named Order, made on 1st May 2015, was confirmed without modification on 31st July 2015.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding to them a footpath commencing from The Drive (public highway) at TL 3197 0305 running generally south south-east between the boundaries of numbers 18 and 20 for approximately 45m to the access road at the rear of properties on The Drive and Cuffley Hill at TL 3198 0301 then continuing south east between the boundaries of numbers 46 and 50 Cuffley Hill for approximately 50m to join Cuffley Hill (public highway) at TL 3201 0296.

A copy of the order and the order plan may be seen free of charge at front reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and at Broxbourne Borough Council, Churchgate, Cheshunt EN8 9XQ. Copies of the order and plan may be bought at the price of £2.

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 13th August 2015, make application for the purpose of the High Court.

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(b) of the Act, namely the expiration, in relation to any way in the area to which the Map relates, of any period such that the enjoyment by the public of the way during that period raises the presumption that the way has been dedicated as a public path or restricted byway.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 14th April 2015
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan attached to the Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Cheshunt 82) Modification Order 2015.

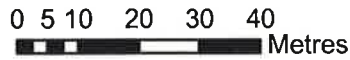

A footpath commencing from The Drive (public highway) at TL 3197 0305 (point A on the Order Plan) running generally south south-east between the boundaries of numbers 18 and 20 for approximately 45m to the access road at the rear of properties on The Drive and Cuffley Hill at TL 3198 0301 (point B on the Order Plan). Continuing south east between the boundaries of numbers 46 and 50 Cuffley Hill for approximately 50m to join Cuffley Hill (public highway) at TL 3201 0296 (point C on the Order Plan).

Width: Varies between 1.3m and 3m as shown shaded grey on Inset Plan 1 of the Order Plan.
