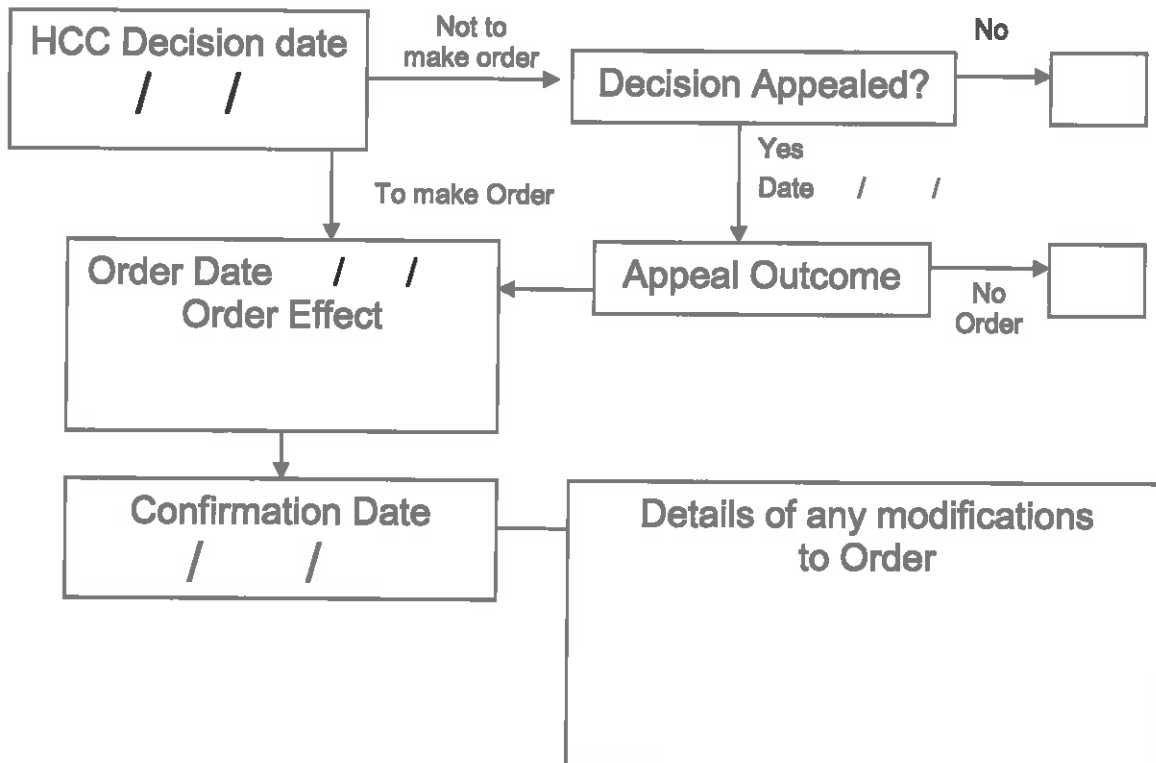

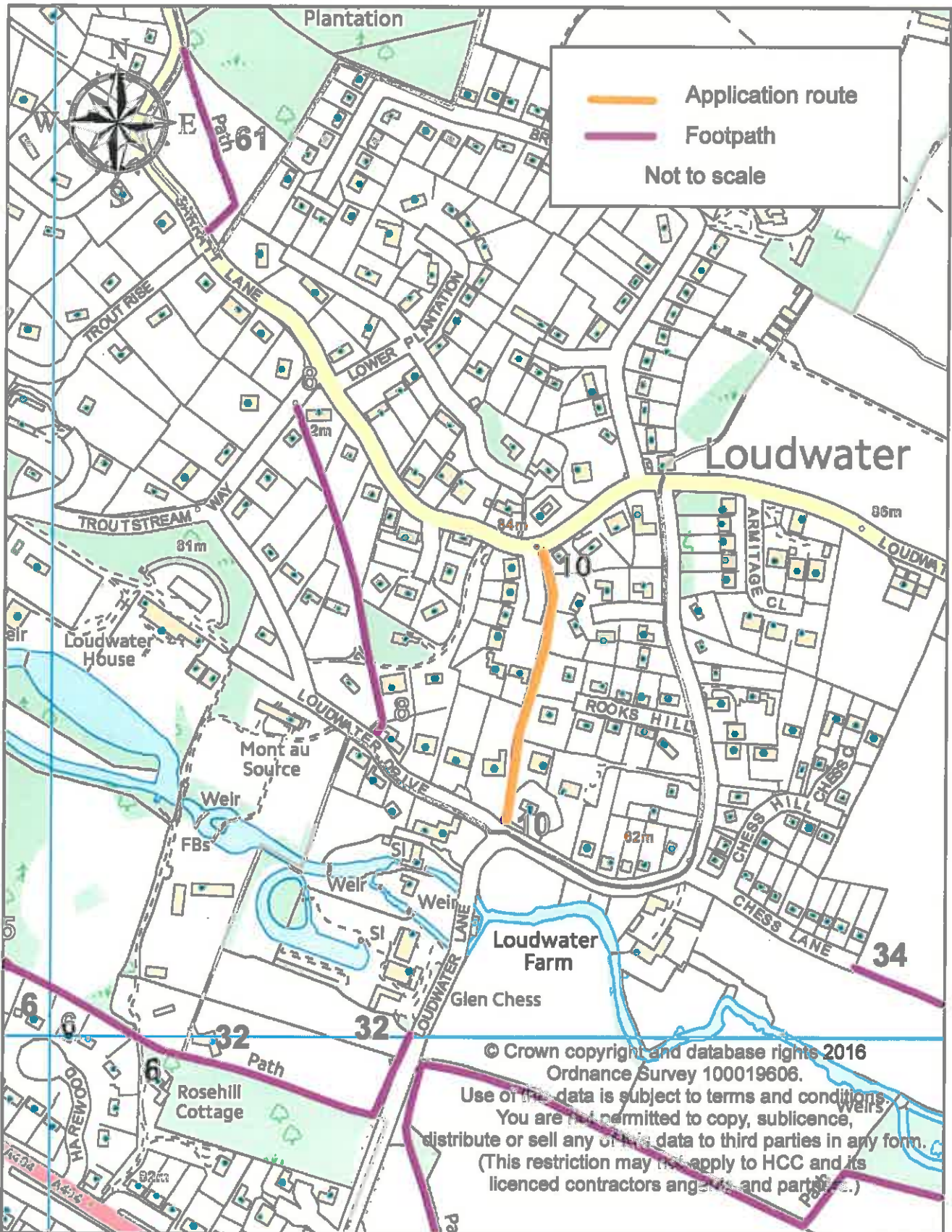

Upgrading to a restricted byway the footpath Chorleywood 10 FP from Loudwater Lane to Sarratt Lane, in Loudwater

Varying the particulars relating to the 'footpath' (Chorleywood 10) from Loudwater Lane to Sarratt Lane by providing that the width is that shown excluded from the hereditaments on the Finance Act 1910 Valuation Plan and that there are no limitations or conditions on the use of the route by the public

and shown on the map accompanying this application.
