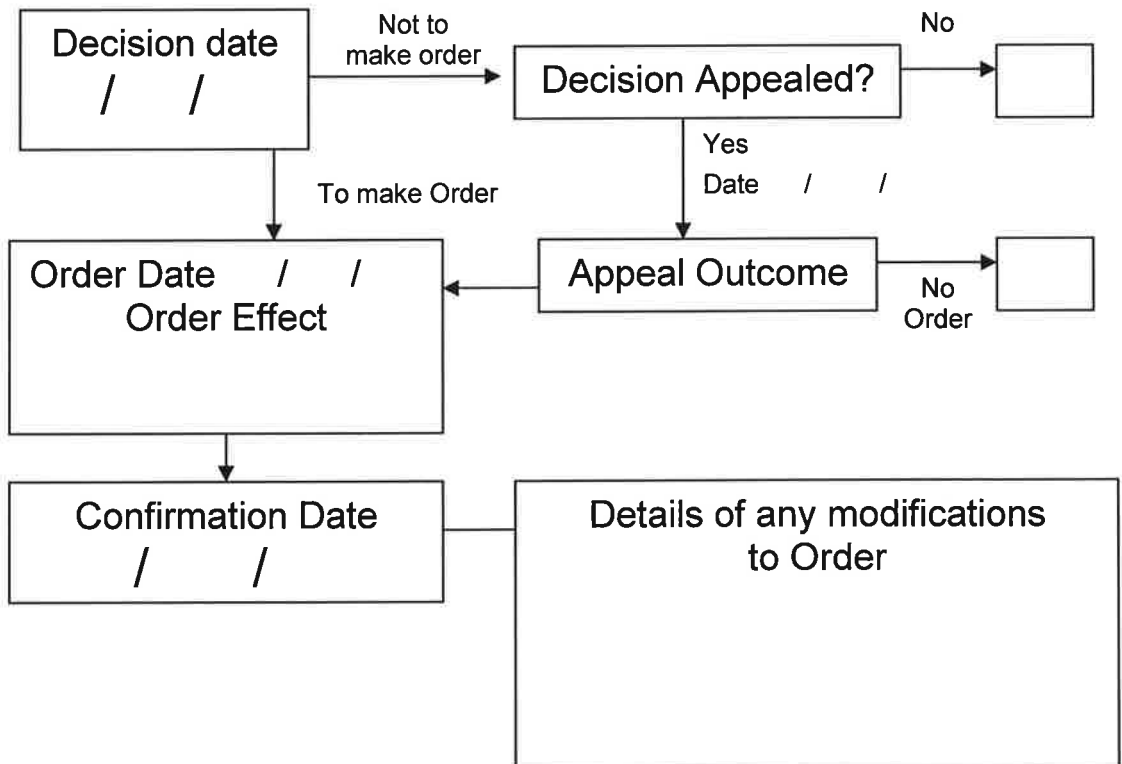

- (1) Upgrading to restricted byway the bridleway from Burymead Lane (Cottered 17 BOAT) to Flanders Green, and
- (2) Adding the restricted byway from (1) at Flanders Green to a junction with the county road at Cottered Warren,

and shown on the map accompanying this application.
