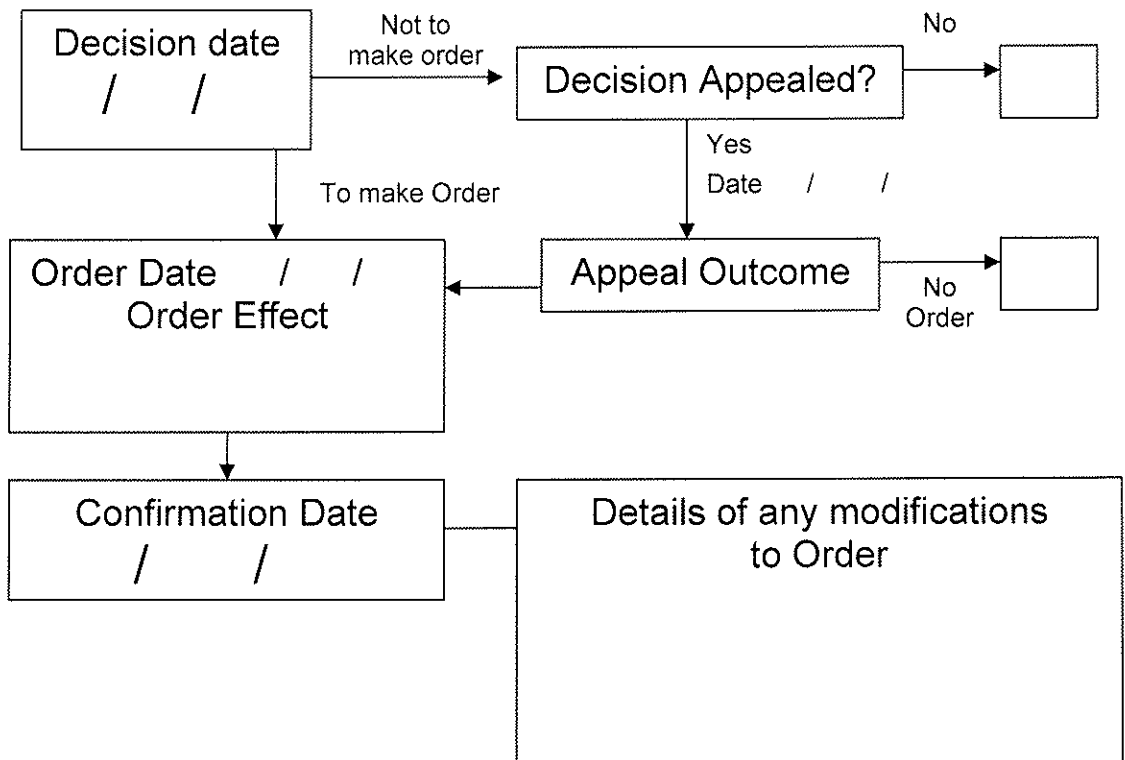

I, Dr Philip David Wadey of 12 Home Close, Corsham, Wiltshire SN13 0BE hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

[A] Adding the byway open to all traffic ("King's Lane") from Albury Road to Furneux Pelham 13 BOAT.

[B] Upgrading to restricted byway the footpath (part of Furneux Pelham 17) from [A above] to a junction with Furneux Pelham 13A

[C] Upgrading to a restricted byway the footpath (Furneux Pelham 13A) from [B above] to the county road from Kings to Hixham Hall,,

and shown on the map accompanying this application.
