

PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980, SECTION 119

HERTFORDSHIRE COUNTY COUNCIL

**Hertfordshire County Council (Great Munden 31)
Public Path Diversion Order 2012**

This Order is made by Hertfordshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Mr J White has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

East Herts Council and Great Munden Parish Council have been consulted in as required by section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over the land situate at Levens Green, Great Munden parish shown by a bold continuous line on the plan forming part of this Order ("the Order Plan") and described in Part 1 of the Schedule to this Order ("the Schedule") shall be stopped up 7 days from the date of confirmation of this Order.
3. There shall 7 days after the date of confirmation of this Order be a public footpath over the land situate at Levens Green, Great Munden parish described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That part of Great Munden Footpath 31 commencing from point A on the Plan forming part of this Order ("the Order Plan") (TL 3565 2254) and continuing in a generally north north westerly direction through the buildings and across the field for approximately 120 metres to point C on the Order Plan (TL 3559 2264).

PART 2

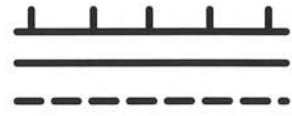
DESCRIPTION OF SITE OF NEW PATH OR WAY

A public footpath commencing at point A on the Order Plan (TL 3565 2254) and continuing in a generally north westerly direction between the track (Great Munden FP34) and the south side of the buildings for approximately 30 metres to point B on the Order Plan (TL 3563 2255) then continuing in a generally north north westerly direction across the field for approximately 90 metres to point C on the Order Plan (TL 3559 2264).

Width: 5 metres

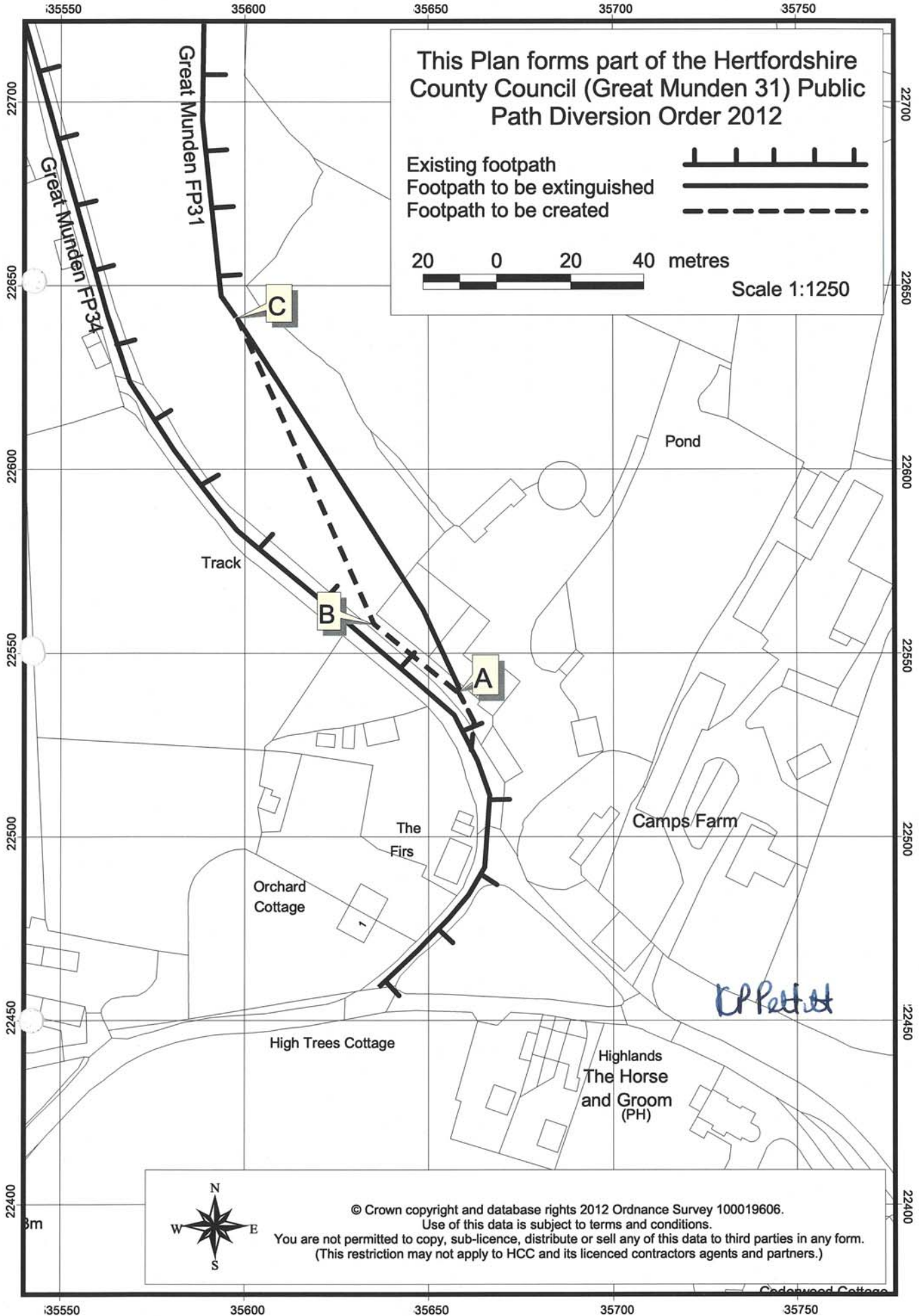
Existing footpath
