

NOTICE OF CONFIRMATION OF A CREATION ORDER

HIGHWAYS ACT 1980, SECTION 26

HERTFORDSHIRE COUNTY COUNCIL

**HERTFORDSHIRE COUNTY COUNCIL (OLD HATFIELD)
CREATION ORDER 2014**

On 13 February 2015, Hertfordshire County Council confirmed without modifications the above Order made under section 26 of the Highways Act 1980.

The effect of the Order as confirmed is to create a public footpath running from Park Street at TL 2341 0872 (Point D on the Order Plan) generally west for approximately 130 metres to a junction with the Great North Road at TL 2328 0871 (Point E on the Order Plan) as shown on the order plan.

A copy of the order and the order plan may be seen free of charge at front reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and at Welwyn Hatfield Borough Council, Council Offices, The Campus, Welwyn Garden City, Herts, AL8 6AE. Copies of the order and plan may be bought from Hertfordshire County Council at the price of £2.

The Order comes into force as from 25 February 2015, but if any person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the grounds that it is not within the powers of the Highways Act 1980, as amended, or on the grounds that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 25 February 2015, make an application to the High Court.

Hertfordshire County Council (Old Hatfield) Creation Order 2014

This Order is made by Hertfordshire County Council ("the authority") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that, having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the path should be created.

Welwyn Hatfield Borough Council has been consulted as required by S26(3) of the 1980 Act.

BY THIS ORDER

1. There shall on the date of confirmation of this Order be a public footpath over the land near Hatfield Railway Station at Old Hatfield described in Part 1 of the Schedule to this Order and shown by a bold broken line on the plan attached to this Order ("the Order Plan").
2. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.

A footpath commencing at a junction with Park Street at TL 2341 0872 (Point D on the Order Plan) generally west for approximately 130 metres to a junction with the Great North Road at TL 2328 0871(Point E on the Order Plan).

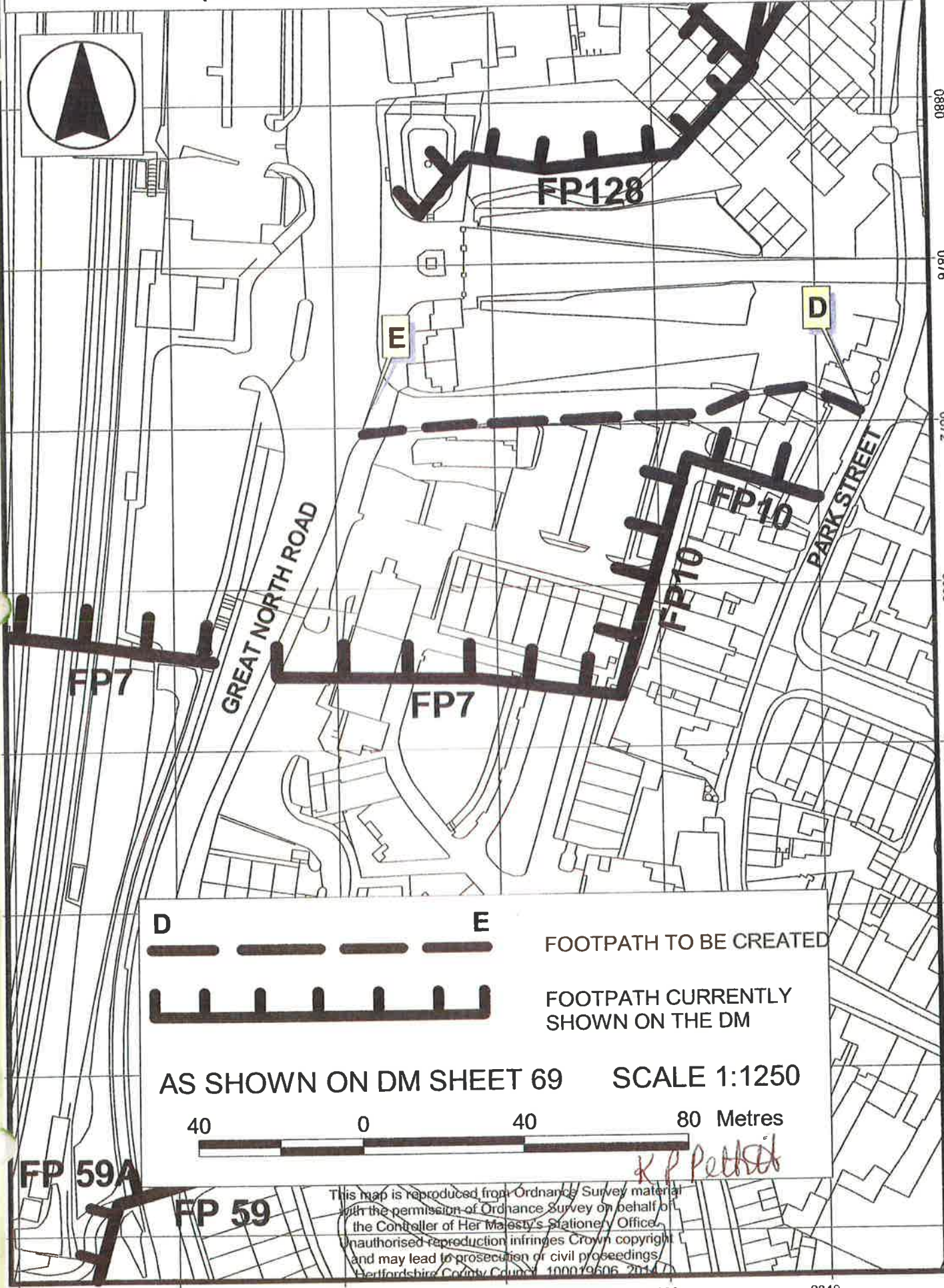
