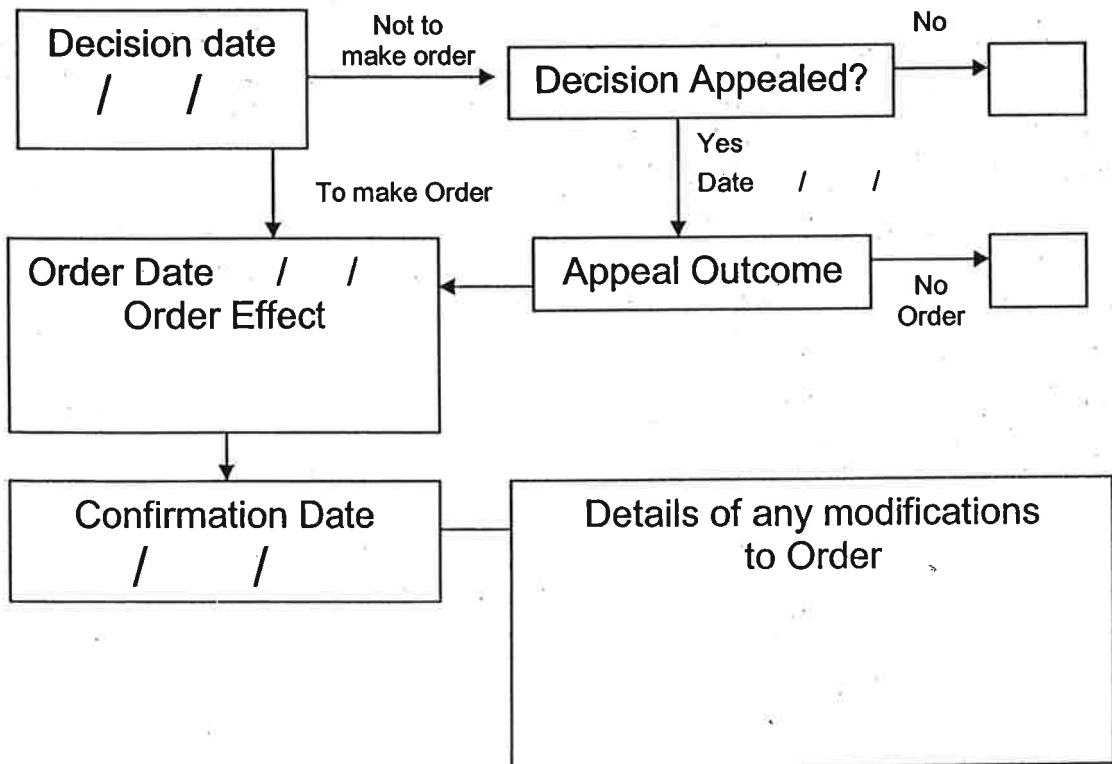

I, Alfred Christopher Pagan, of 10 Highmill, Ware, Hertfordshire, SG12 ORX, hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the county of Hertfordshire by adding the road used as a public path from Stanstead Road, Hertford (grid reference 348130), to the junction of footpath 39, Hertford, and Birdie Way, Hertford (grid reference 348130), with a width of 2 metres and shown on the map annexed hereto.

Extract from the 1953 definitive map for Hertfordshire, showing the claimed path marked as RUPP 40.

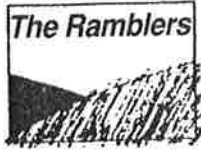
