

NOTICE OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

HERTFORDSHIRE COUNTY COUNCIL

Definitive Map and Statement of Public
Rights of Way in Hertfordshire

The Hertfordshire County Council (Holwell 19) Modification Order 2017

The above Order made on 22nd December 2017, if confirmed as made, will modify the Definitive Map and Statement for the area by:-

Adding to them a footpath commencing at Holwell Road at TL 1677 3331 (Point A on the Order Plan) running south down the driveway to Peter House for 70 metres to TL 1676 3324 (Point B on the Order Plan); continuing east to the south of the building for 40 metres to TL 1680 3324 (Point C on the Order Plan); continuing south south east across a play area and recreation ground for 55 metres to TL 1681 3319 (Point D on the Order Plan); continuing north east along the path for 30 metres to Rands Meadow at TL 1684 3320 (Point E on the Order Plan).

A copy of the Order and the Order Plan may be seen free of charge at Front Reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and at North Herts Council, Gernon Road, Letchworth, SG6 3JF. Copies of the Order and Plan may be bought at the price of £5.

Any representation or objection relating to the Order must be sent in writing to the Definitive Map Officer, Rights of Way Unit, Environment Department, Hertfordshire County Council, County Hall, Hertford, Hertfordshire SG13 8DN (ref: HJD/NH271) to arrive no later than 1st March 2018 and applicants must include particulars of the grounds on which it is made.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, the Hertfordshire County Council, instead of submitting the Order to the Secretary of State may itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment, any representations or objections which have been duly made and not withdrawn will be sent with it.

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(b) of the Act, namely

(b) the expiration, in relation to any way in the area to which the Map relates, of any period such that the enjoyment by the public of the way during that period raises the presumption that the way has been dedicated as a public path or restricted byway.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 18 October 2017.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Holwell 19) Modification Order 2017.

SCHEDULE

PART I

Modification of Definitive Map

DESCRIPTION OF PATH OR WAY TO BE ADDED

A footpath commencing at a junction with Holwell Road (public road) at TL 1677 3331 (Point A on the Order Plan) running generally south down the driveway to Peter House for approximately 70 metres to TL 1676 3324 (Point B on the Order Plan). Then continuing generally east to the south of the building for approximately 40 metres to TL 1680 3324 (Point C on the Order Plan). Then continuing generally south south east across a play area and recreation ground for approximately 55 metres to TL 1681 3319 (Point D on the Order Plan). Then continuing generally north east along the pathway for approximately 30 metres to a junction with Rands Meadow (public road) at TL 1684 3320 (Point E on the Order Plan).

Width: 4 metres between TL 1677 3331 (Point A on the Order Plan) and
TL 1676 3324 (Point B on the Order Plan)

1.5 metres between TL 1676 3324 (Point B on the Order Plan) and

TL 1680 3324 (Point C on the Order Plan)

2 metres between TL 1680 3324 (Point C on the Order Plan) and
TL 1681 3319 (Point D on the Order Plan)

2.5 metres between TL 1681 3319 (Point D on the Order Plan) and
TL 1684 3320 (Point E on the Order Plan).

Limitations: Pedestrian gate at TL 1680 3324 (Point C on the Order Plan)

Kissing gate at TL 1681 3319 (Point D on the Order Plan)

Commences from Holwell Road (public road) at TL 1677 3331 S down the driveway to Peter House for approx. 70m to TL 1676 3324 continuing E to the S of the building for approx. 40m to TL 1680 3324 continuing SSE across the play area and the recreation ground for approx. 55m to TL 1681 3319 continuing NE along a pathway for approx. 30m to join Rands Meadow (public road) at TL 1684 3320.

Width 4m between TL 1677 3331 and TL 1676 3324
1.5m between TL 1676 3324 and TL 1680 3324
2m between TL 1680 3324 and TL 1681 3319
2.5m between TL 1681 3319 and TL 1684 3320

Limitations Pedestrian gate at TL 1680 3324
Kissing gate at TL 1681 3319

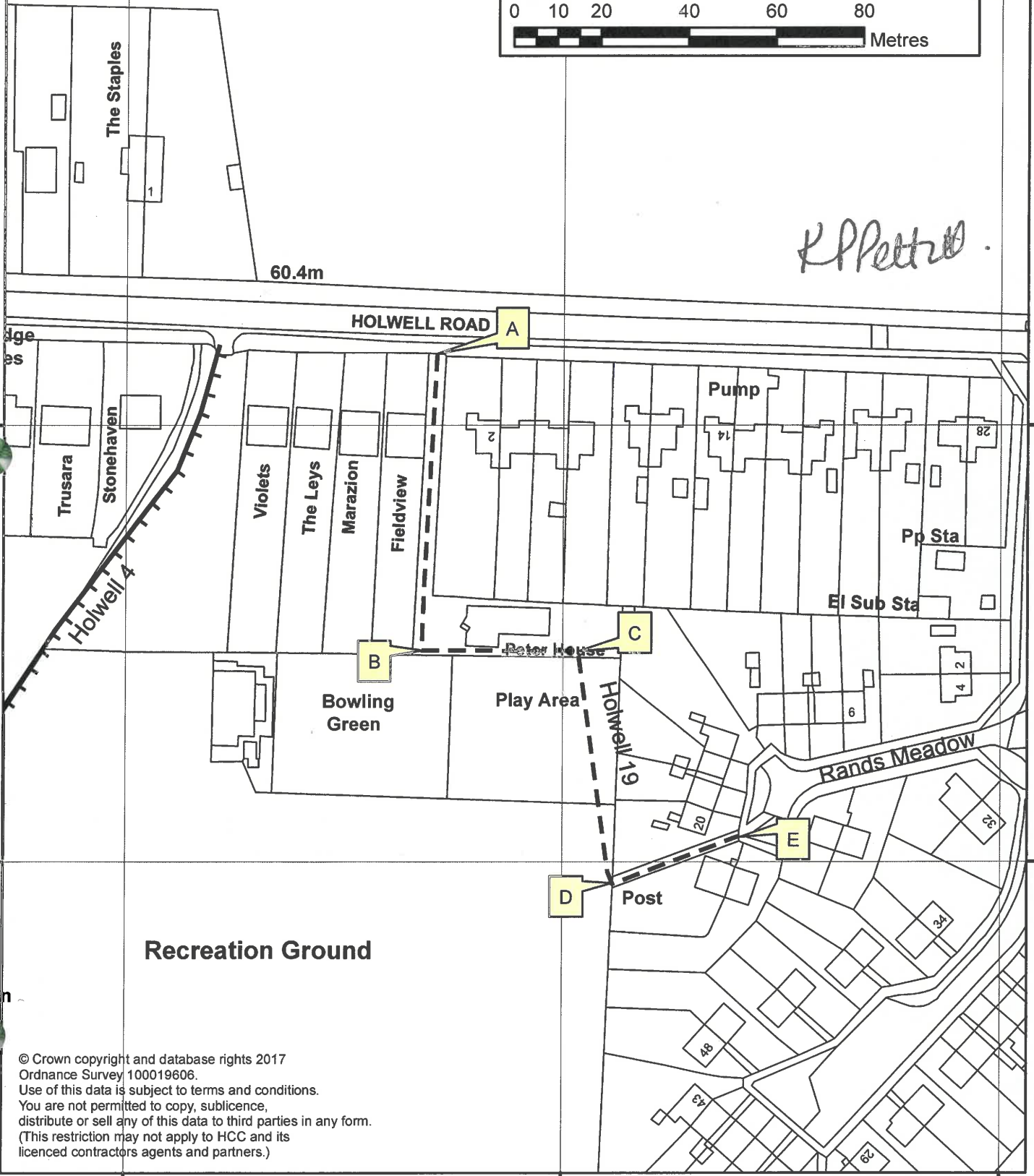
