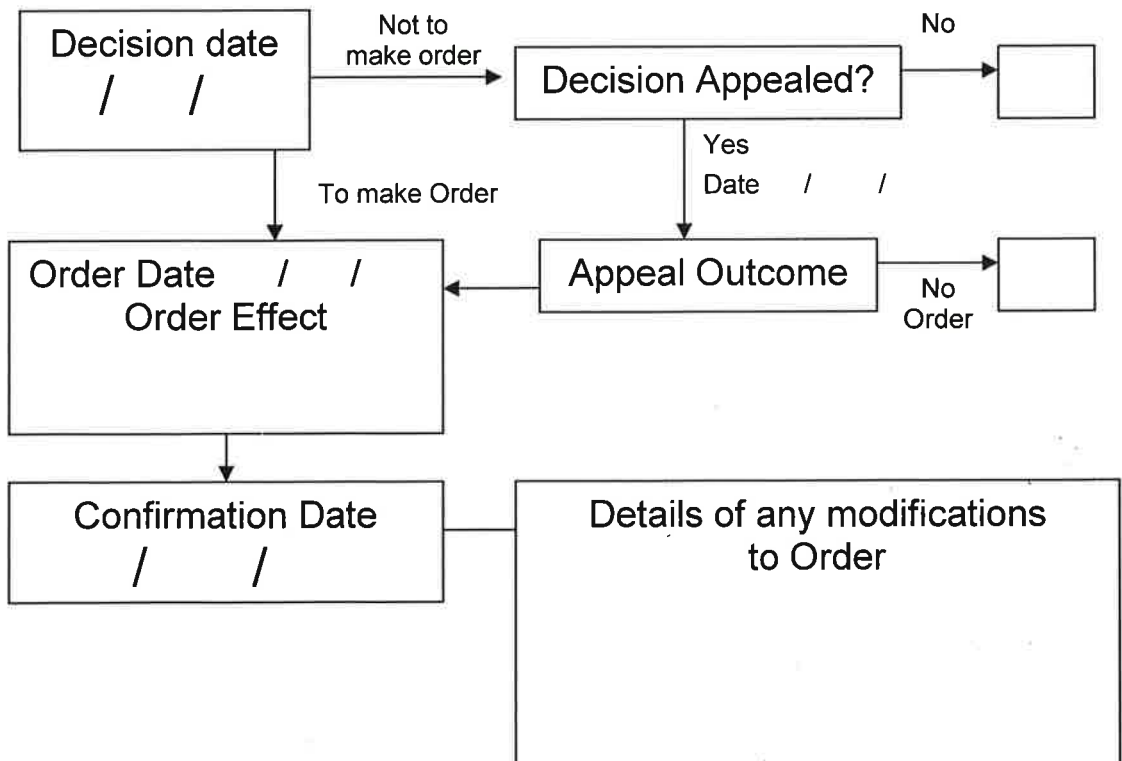

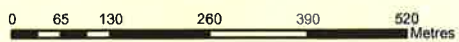

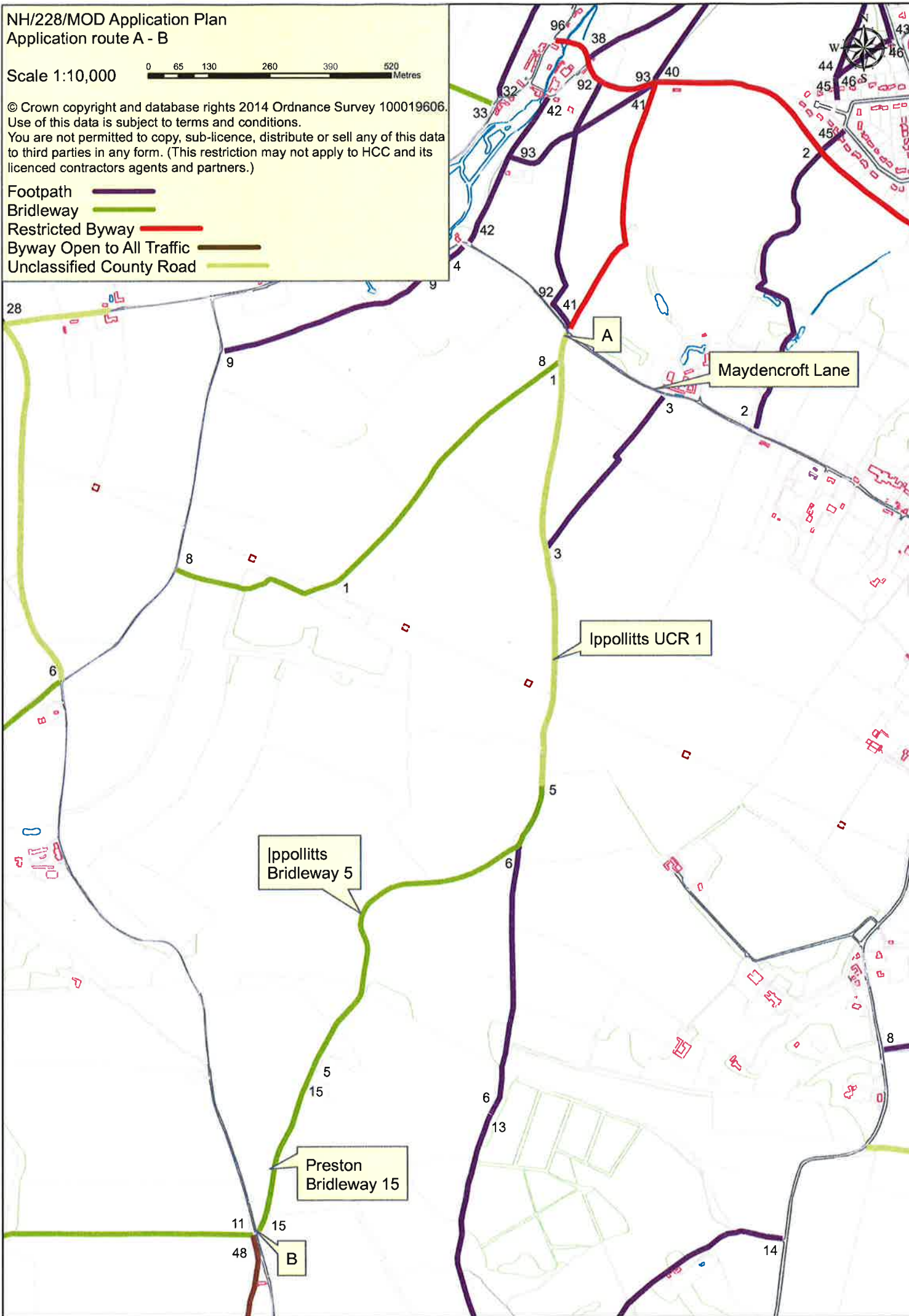
NH/228/MOD Application Plan

I, Dr Philip David Wadey of 12 Home Close, Corsham, Wiltshire SN13 0BE hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

- (1) Adding the restricted byway from Maydencroft Lane to Ippollitts 5 BW
- (2) Upgrading to restricted byway the bridleway (Ippollitts 5 BW) from route (1) above to Preston 15 BW
- (3) Upgrading to restricted byway the bridleway (Preston 15 BW) from Ippollitts 5 BW to Sootfield Green and Dead Woman's Lane (Kings Walden 48 BOAT)

and shown on the map accompanying this application.
