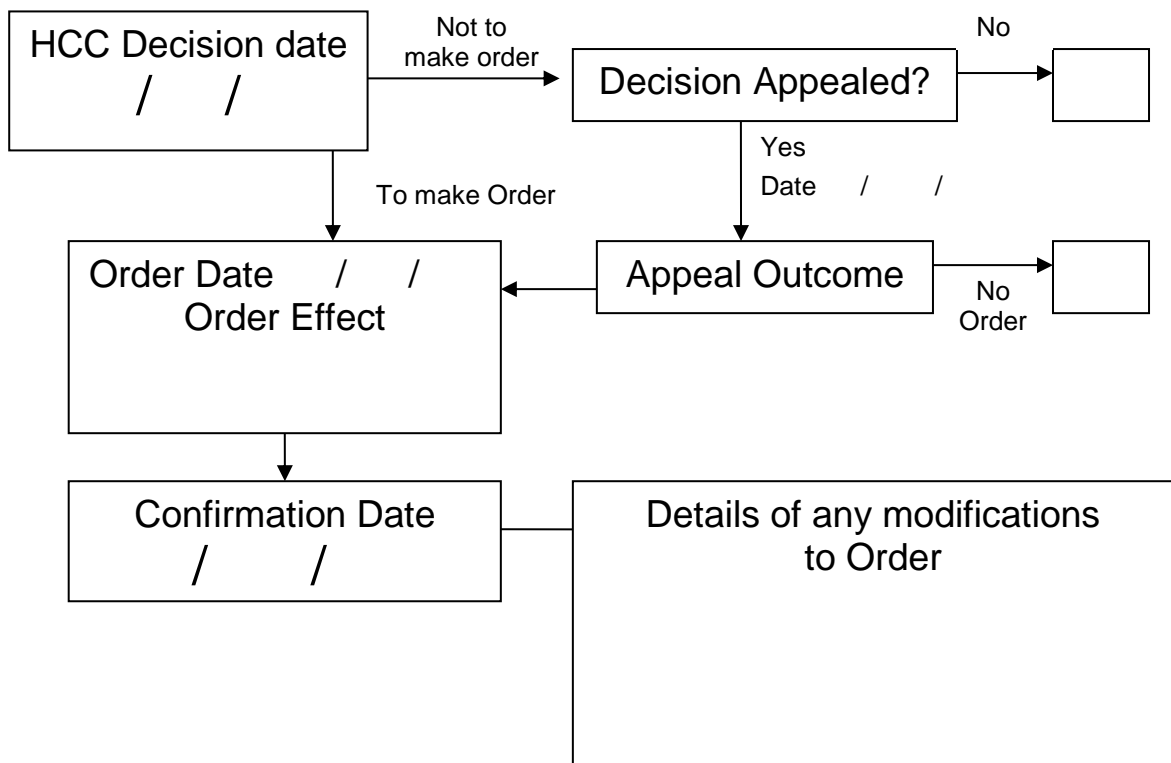

Adding the restricted byway from Hyde  BW at the county boundary with Bedfordshire to the junction of Hyde Lane and Farr's Lane

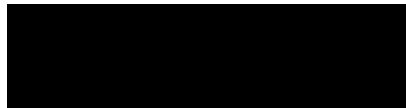



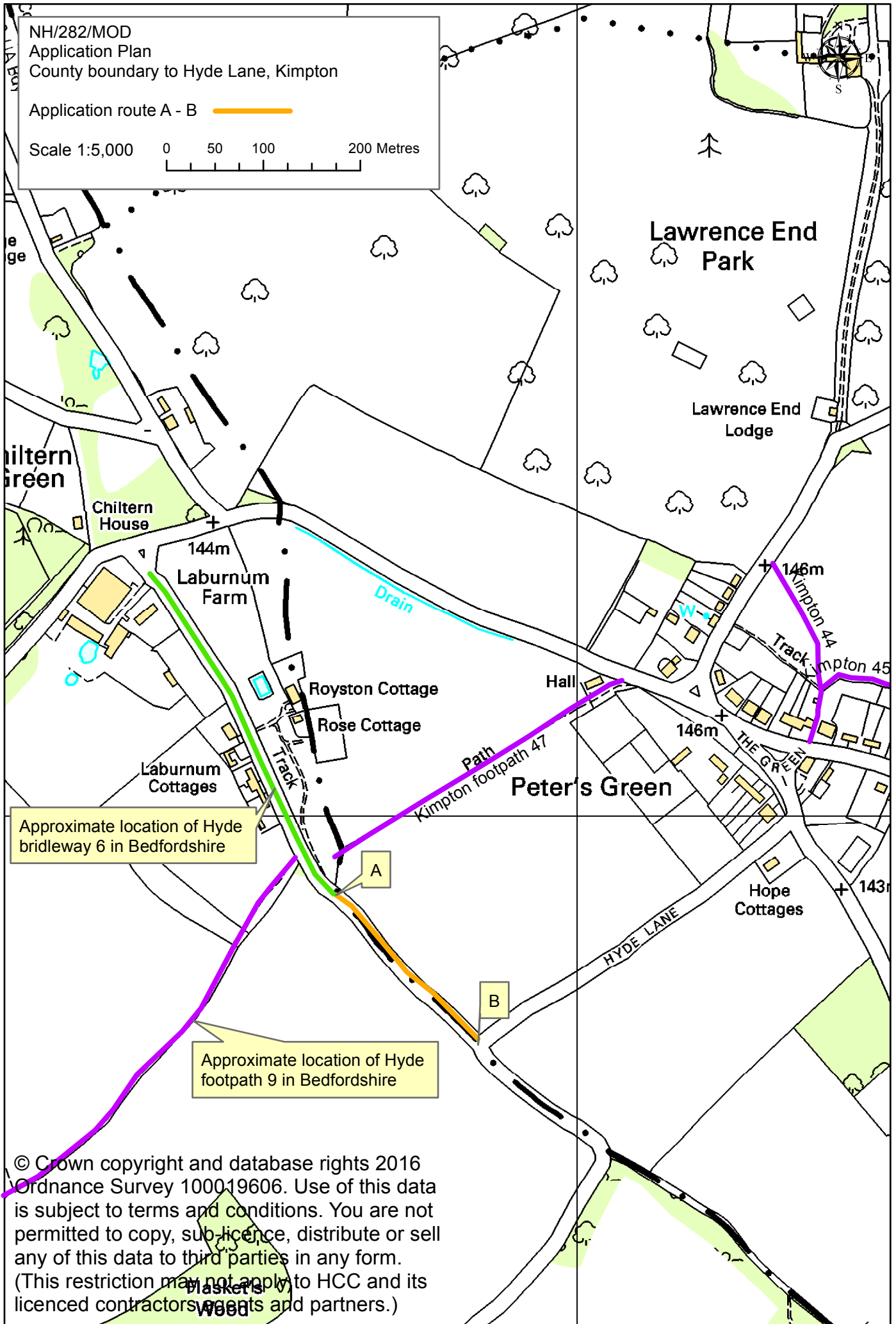
