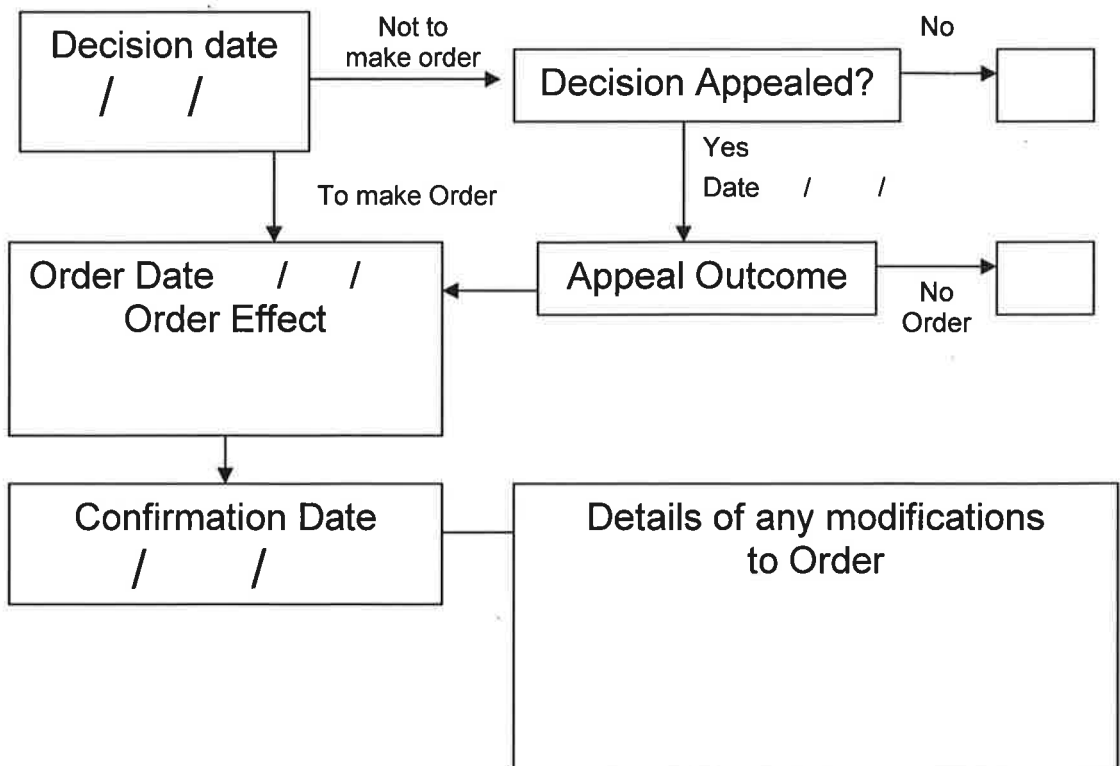

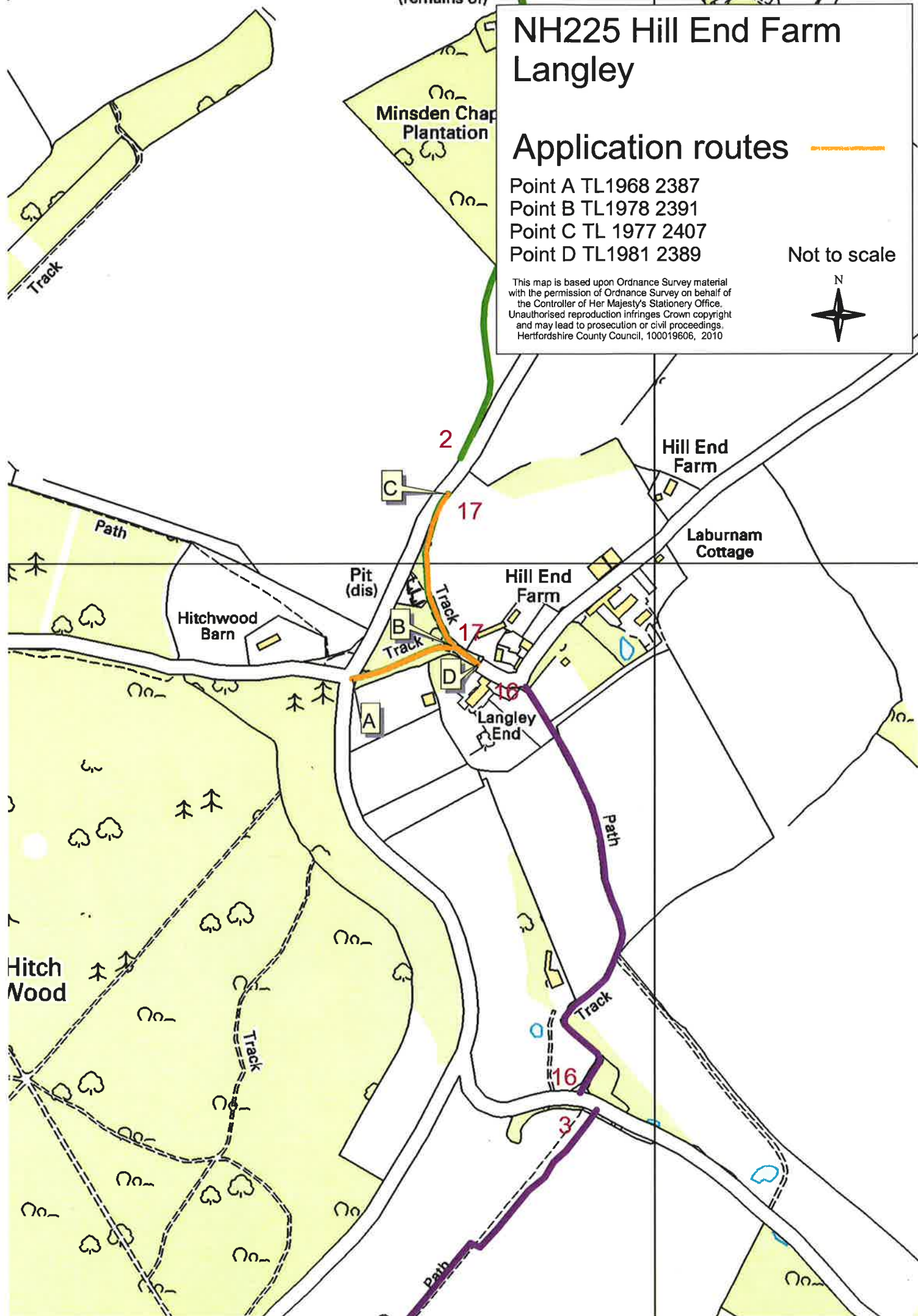
NH225 Hill End Farm Langley
