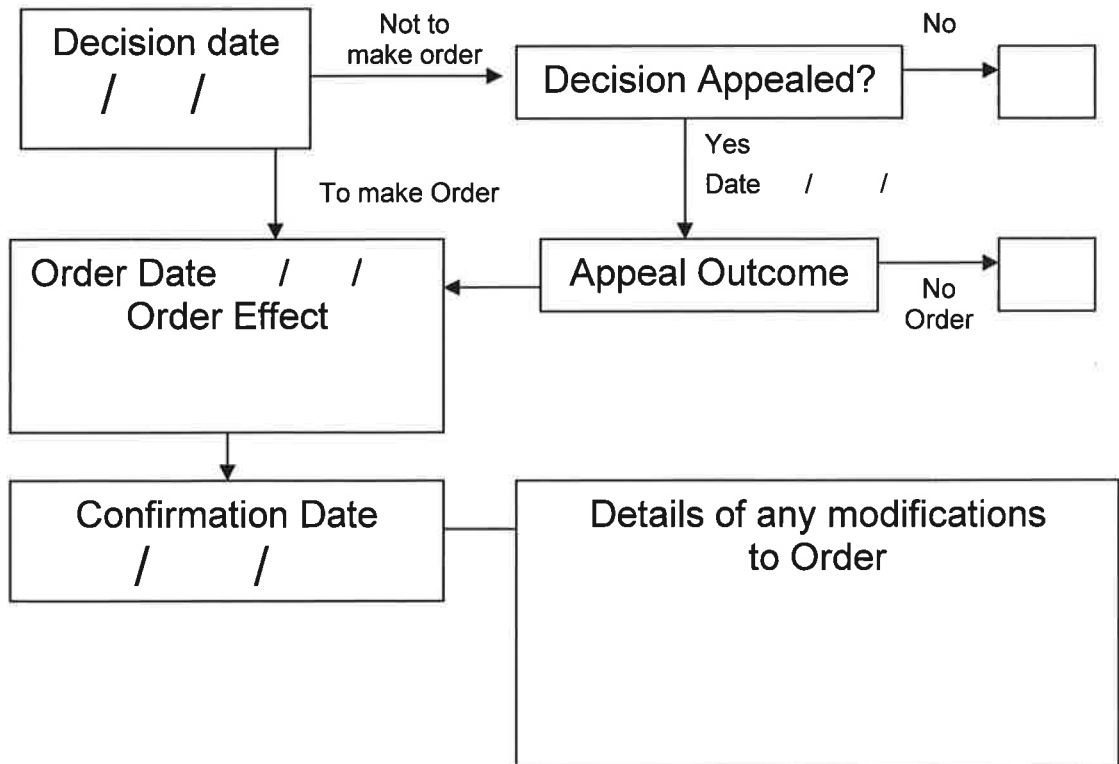

Adding the restricted byway from Roxley Court Road (Point A on the Map accompanying this application) to the junction of Letchworth 1 BW and Letchworth 2 BW (point B on the Map), and

Upgrading to restricted byway the bridleway (part of Letchworth 2 BW) from Point B on the Map, to point C on the Map

and shown on the Map accompanying this application.
