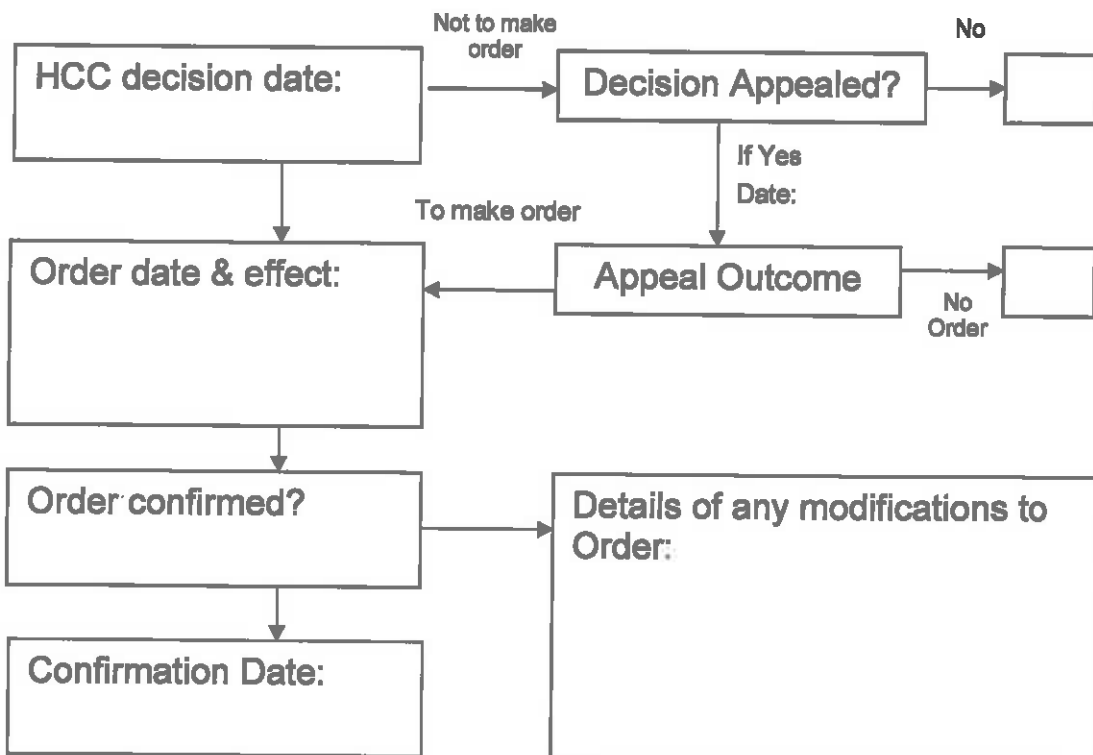

I, Dr Philip David Wadey of 12 Home Close, Corsham, Wiltshire SN13 0BE hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

Adding the byway open to all traffic from Abbots Langley 40 FP (Point C) to Abbots Langley 58 FP (Point D).

Upgrading to a byway open to all traffic the footpath from Abbots Langley 40 BW (Point A) to gazetteer route 3U96/10 (Point C)

Adding to the particulars relating to the footpath/byway open to all traffic from Abbots Langley 40 BW to Abbots Langley 58 FP by providing that the width is that shown excluded from the hereditaments on the Finance Act 1910 Valuation Plan, the name of the route is Gypsy Lane, and that there are no limitations or conditions on the use of the routes by the public

and shown on the map accompanying this application.
