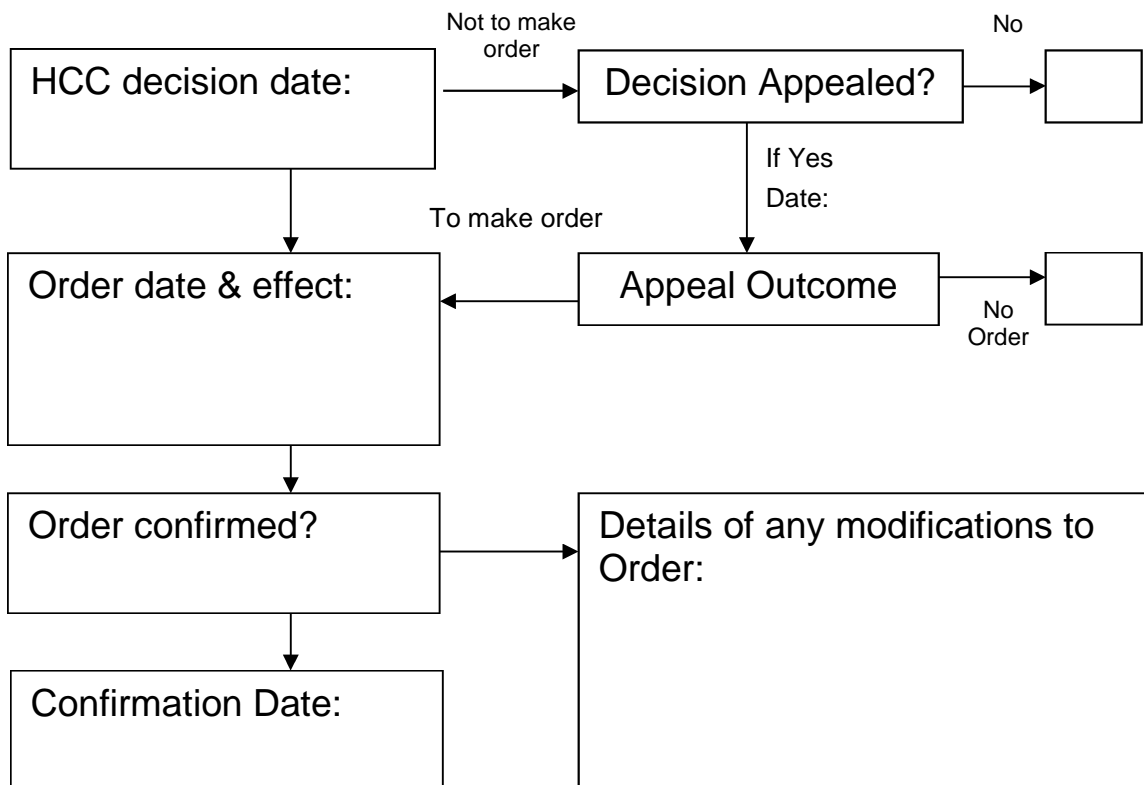



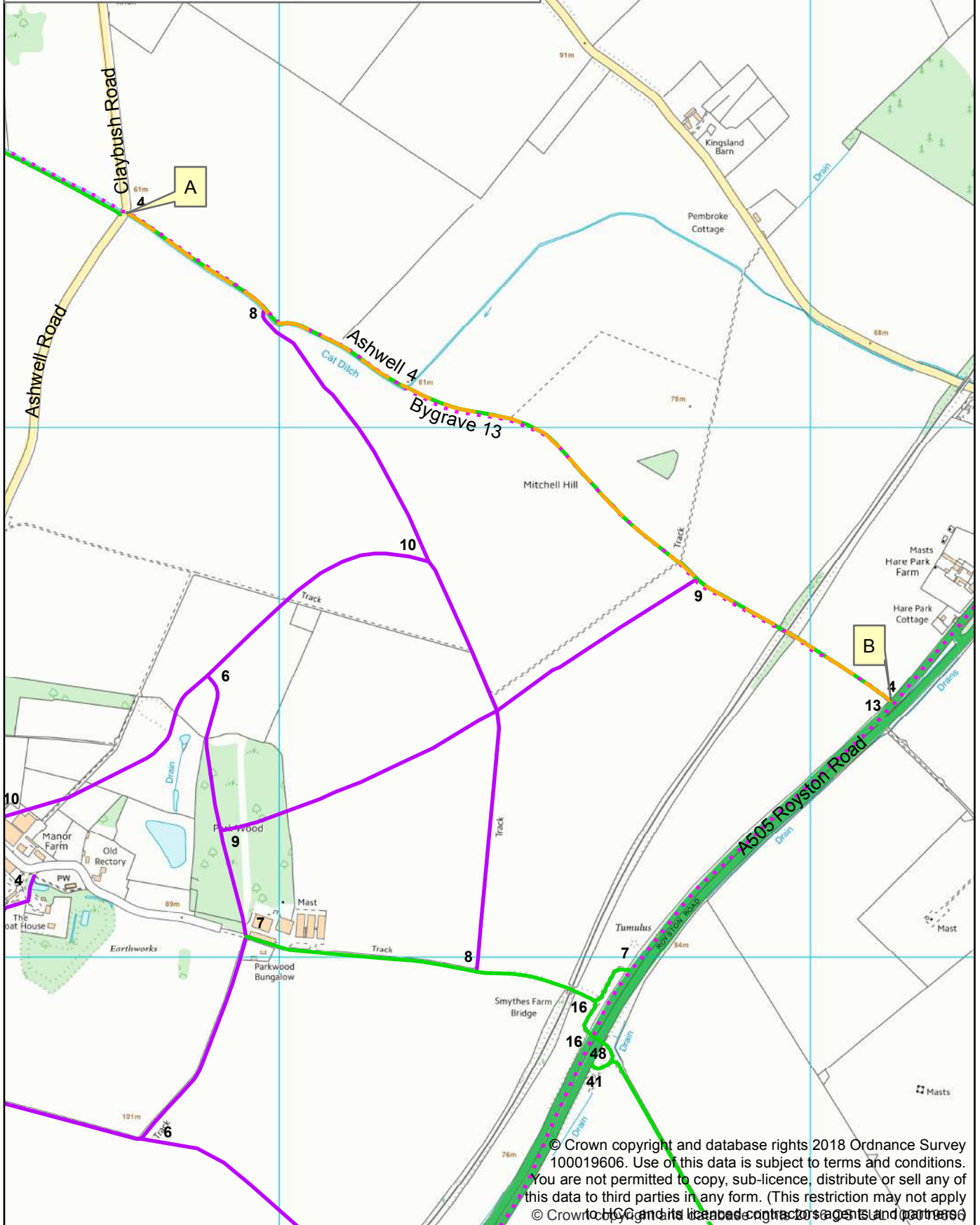


NH/309/MOD Application Plan

Upgrading to a restricted byway the bridleway (Ashwell 4 and Bygrave 13 (part)) from Royston Road to the road known variously as Claybush Road, Ashwell or Ashwell Road, Bygrave

Adding to the particulars relating to the bridleway/restricted byway (Ashwell 4 and Bygrave 13 (part)) from Royston Road to the road known variously as Claybush Road, Ashwell or Ashwell Road, Bygrave by providing that the width is that shown excluded from the hereditaments on the Finance Act 1910 Valuation Plan and that there are no limitations or conditions on the use of the route by the public

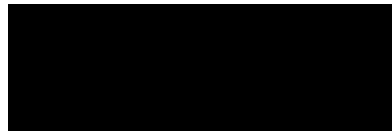
