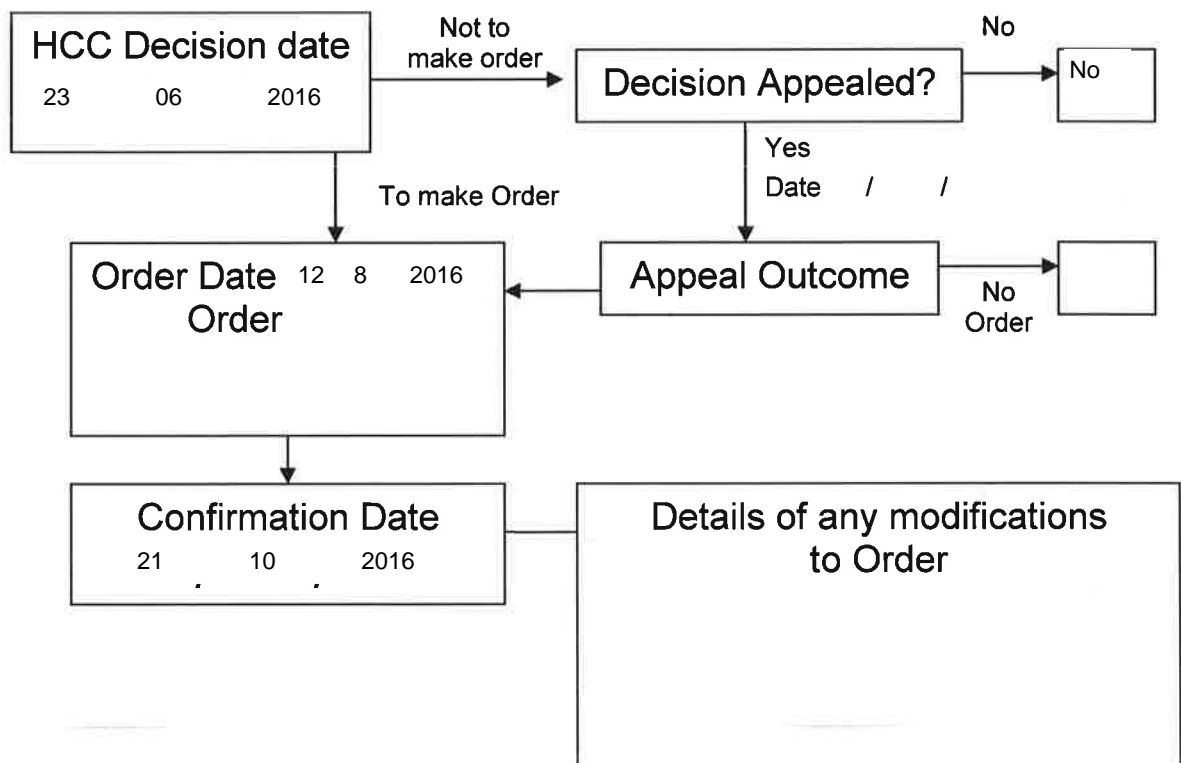

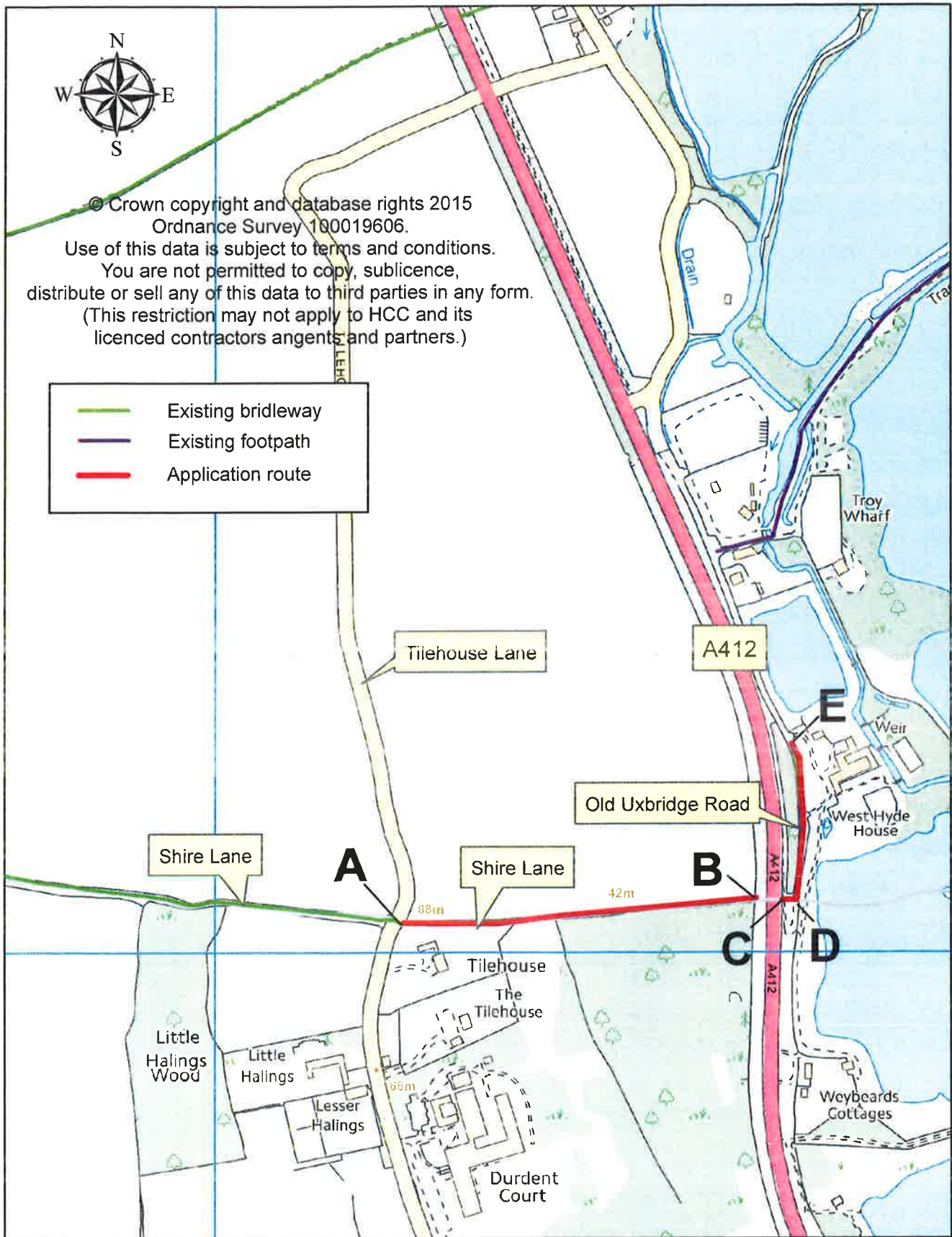

I, Dr Philip David Wadey of 12 Home Close, Corsham, Wiltshire SN13 0BE hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

- Upgrading to a restricted byway, the bridleway (part of Rickmansworth 2 BW) from Tilehouse Lane (Point A) to Denham Way (Point B),
- Adding the restricted byway from Denham Way (Point C) to the Old Uxbridge Road (Point D),
- Adding the byway open to all traffic from Point D above northwards along the Old Uxbridge Road to the bollards at Point E,

and shown on the map accompanying this application.
