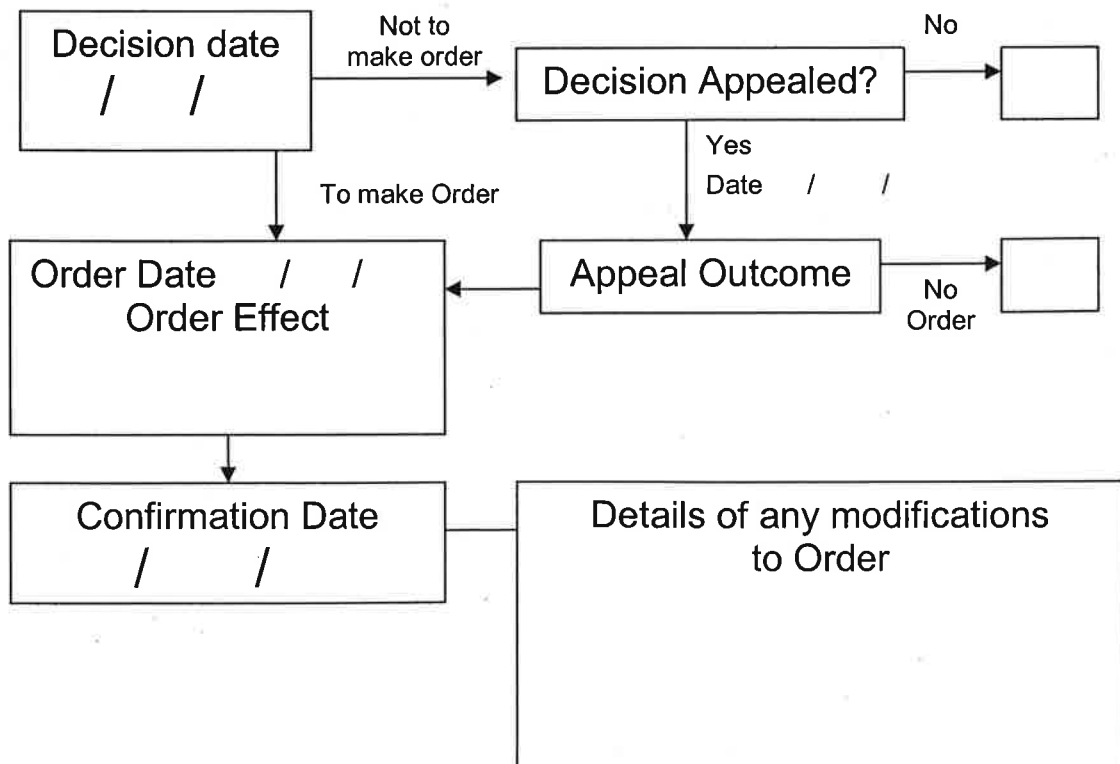

We, John Hebditch of 10 Cadogan House, Beaufort Street, Chelsea, London SW3, and Dr Philip David Wadey of Holland Farm, ALDENHAM, Hertfordshire WD2 8DJ, hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

- 1 **adding the bridleway** from the county road (Tollgate Road) at Grid Ref TL 2271 0436, thence generally northwest and round a corner, with a width of 12' to a junction with FP 6 North Mymms at Grid Ref TL 2269 0436;
- 2 **upgrading to bridleway the footpath** (part of FP 6 North Mymms) from Grid Ref TL 2269 0436 eastwards with a width of 12' to the end of the definitive path at Grid Ref TL 2273 0436;
- 3 **adding the bridleway** from Grid Ref TL 2273 0436 thence eastwards over the A1(M) motorway with a width of 10' to Grid Ref TL 2278 0437, thence generally southwards with a width varying between 12' and 16' to a junction with Swanland Road (formerly known as Barnet By-Pass Road) at Grid Ref TL 2282 0426,

as shown on the map accompanying this application.

- Extract from 'The A1(M) Motorway and Connecting Roads Cecil Road to Roestock Section (Appropriation and Side Roads) Order 197' (*Draft order only*).
