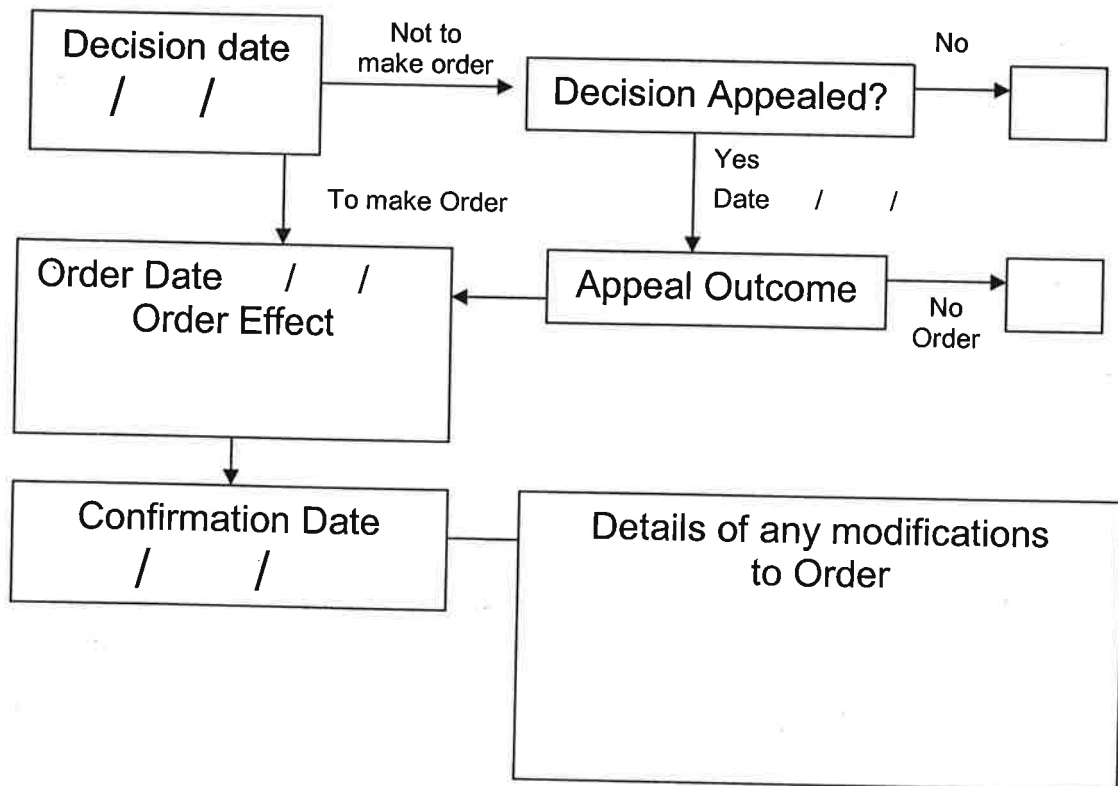

I, Dr Philip David Wadey of Holland Farm, Hilfield Lane, Aldenham, Hertfordshire WD2 8DJ hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by adding to the particulars relating to the footpath (Potters Bar 72) from the junction of St Albans Road and Dancers Hill Road to the county road west of Dancers Hill House by providing that:

- the width of the path lies between specified values (see Applicant's Statement);
- the path has the name 'Laurel Lodge Lane'; and
- there are no lawful limitations or obstructions on the use of this route by the public

and shown on the map accompanying this application.

I attach copies of the following documentary evidence (including statements of witnesses) in support of this application:

- HM Land Registry plan showing extent of ownership on one side
- Statement by the Applicant

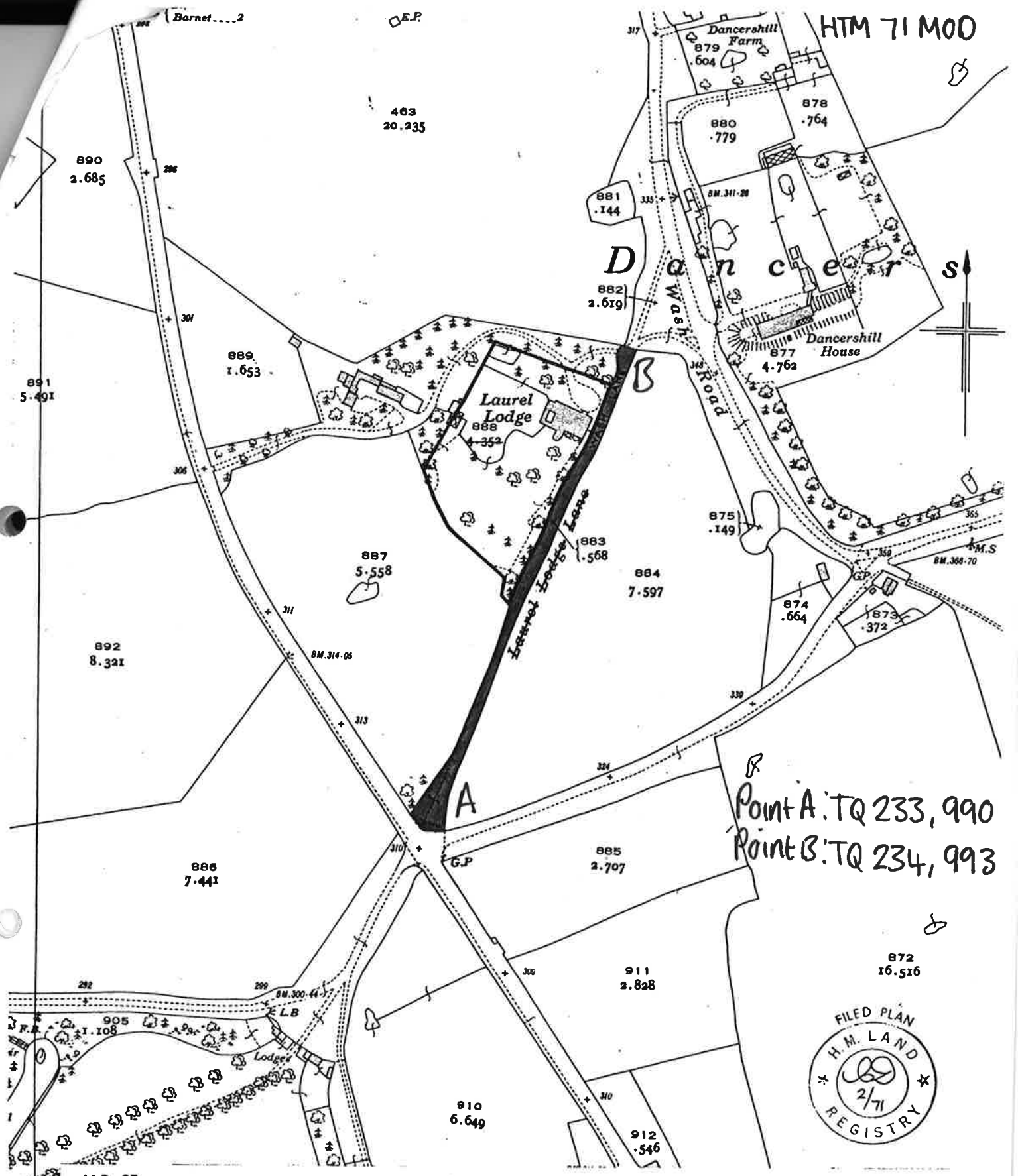
