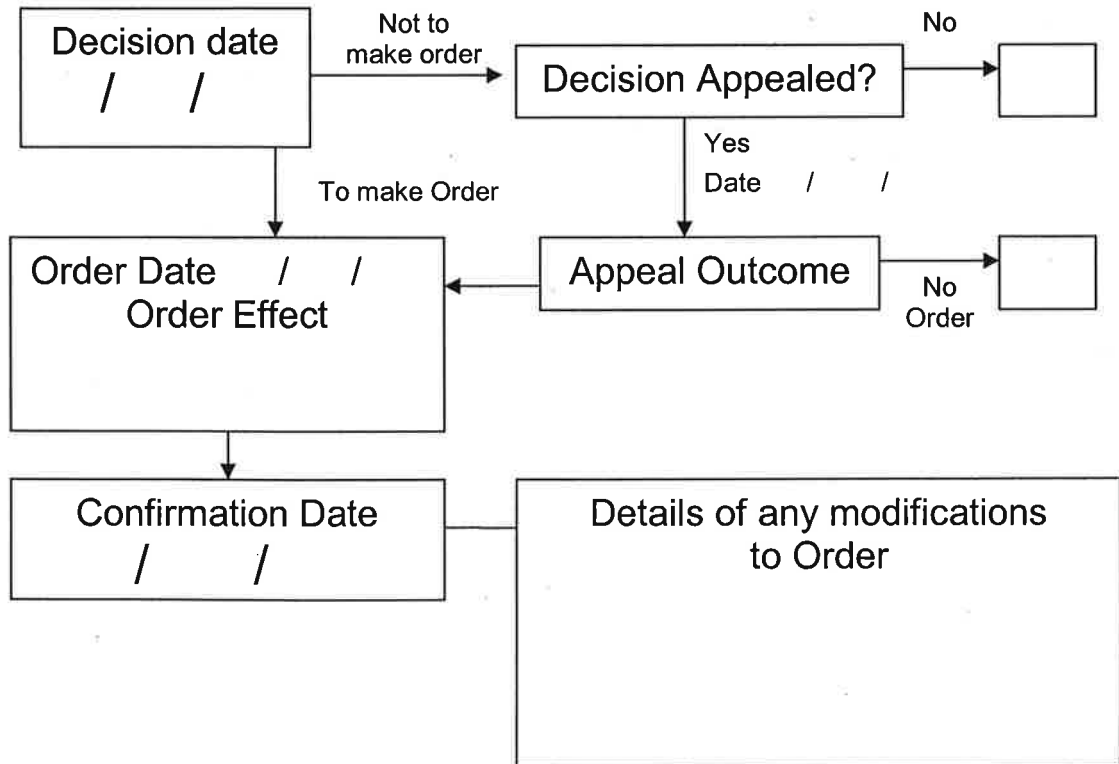

I, Dr Philip David Wadey of 67 Cherry Close, Knebworth, Hertfordshire SG3 6DS hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

- adding the byway open to all traffic known as 'Wash Lane' from Potters Bar 75 BW to Swanland Road and shown on the map accompanying this application.

I attach copies of the following documentary evidence (including statements of witnesses) in support of this application:

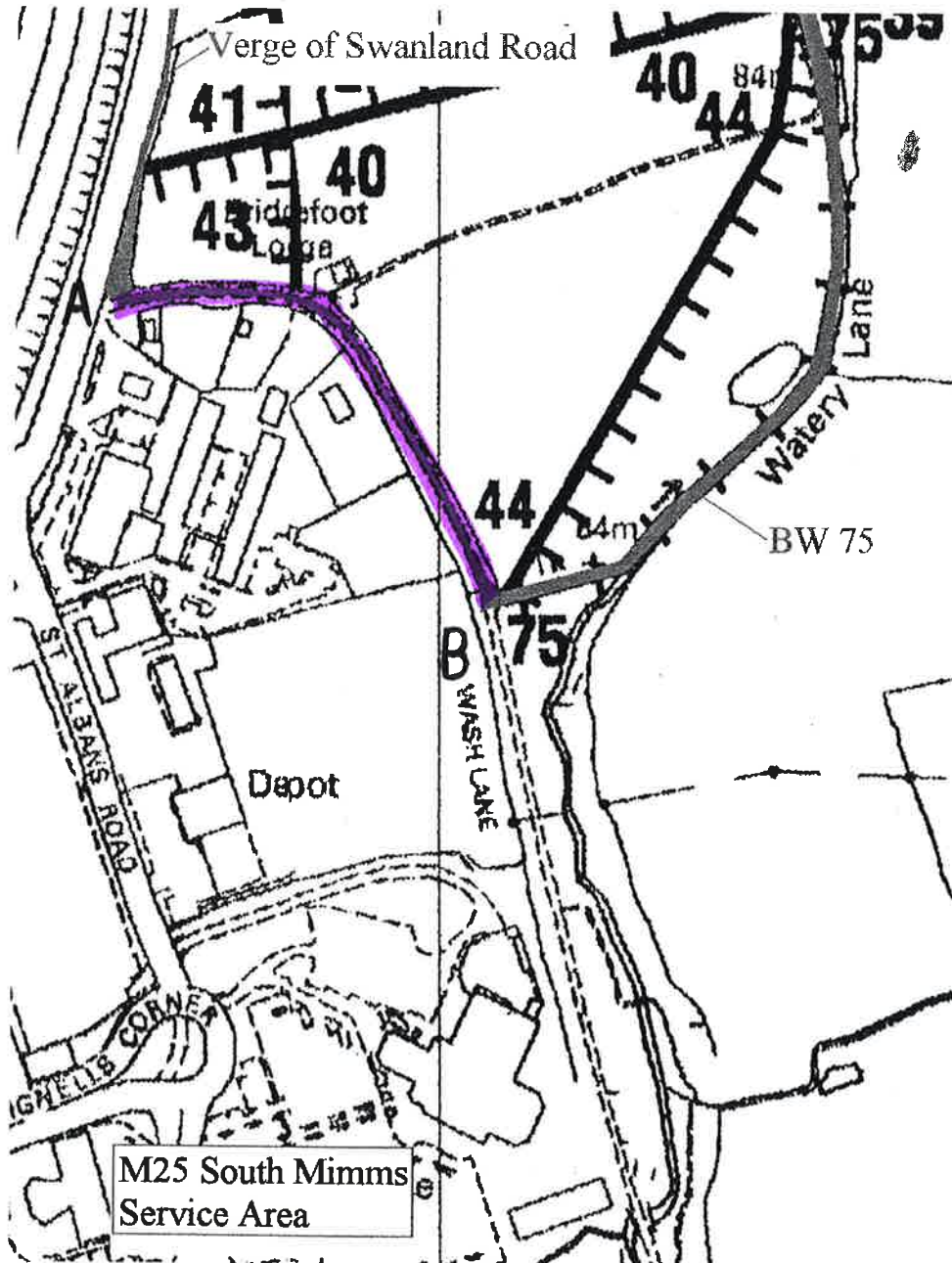
- Extract from 1st edition of the one-inch Ordnance Survey map, sheet 71 "London and Windsor" showing the physical route.

- 12 evidence forms showing equestrian user of the route. These demonstrate that the route has been used by the public on horseback since 1962, and that the users consider the route mainly to be used by walkers and/or riders.
