

NOTICE OF CONFIRMATION OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

Definitive Map and Statement of Public Rights of Way in Hertfordshire

**Hertfordshire County Council
(Rickmansworth 69) Modification Order 2015**

The above named Order, made on 10th September 2015, was confirmed without modification on 4th December 2015.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding to them a footpath commencing from Aldbury Road (public highway) at TL 0395 9483 running generally south south-east between the boundaries of numbers 8 and 10 Aldbury Road and numbers 19 and 21 Chiltern Drive for approximately 55m to join Chiltern Drive (public highway) at TL 0398 9479.

A copy of the order and the order plan may be seen free of charge at front reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and at Three Rivers District Council, Three Rivers House, Northway, Rickmansworth, Hertfordshire WD3 1RL. Copies of the order and plan may be bought at the price of £2.

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 18th December 2015, make application for the purpose of the High Court.

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(b) of the Act, namely the expiration, in relation to any way in the area to which the Map relates, of any period such that the enjoyment by the public of the way during that period raises the presumption that the way has been dedicated as a public path or restricted byway.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 3rd September 2015.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan attached to the Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Rickmansworth 69) Modification Order 2015.

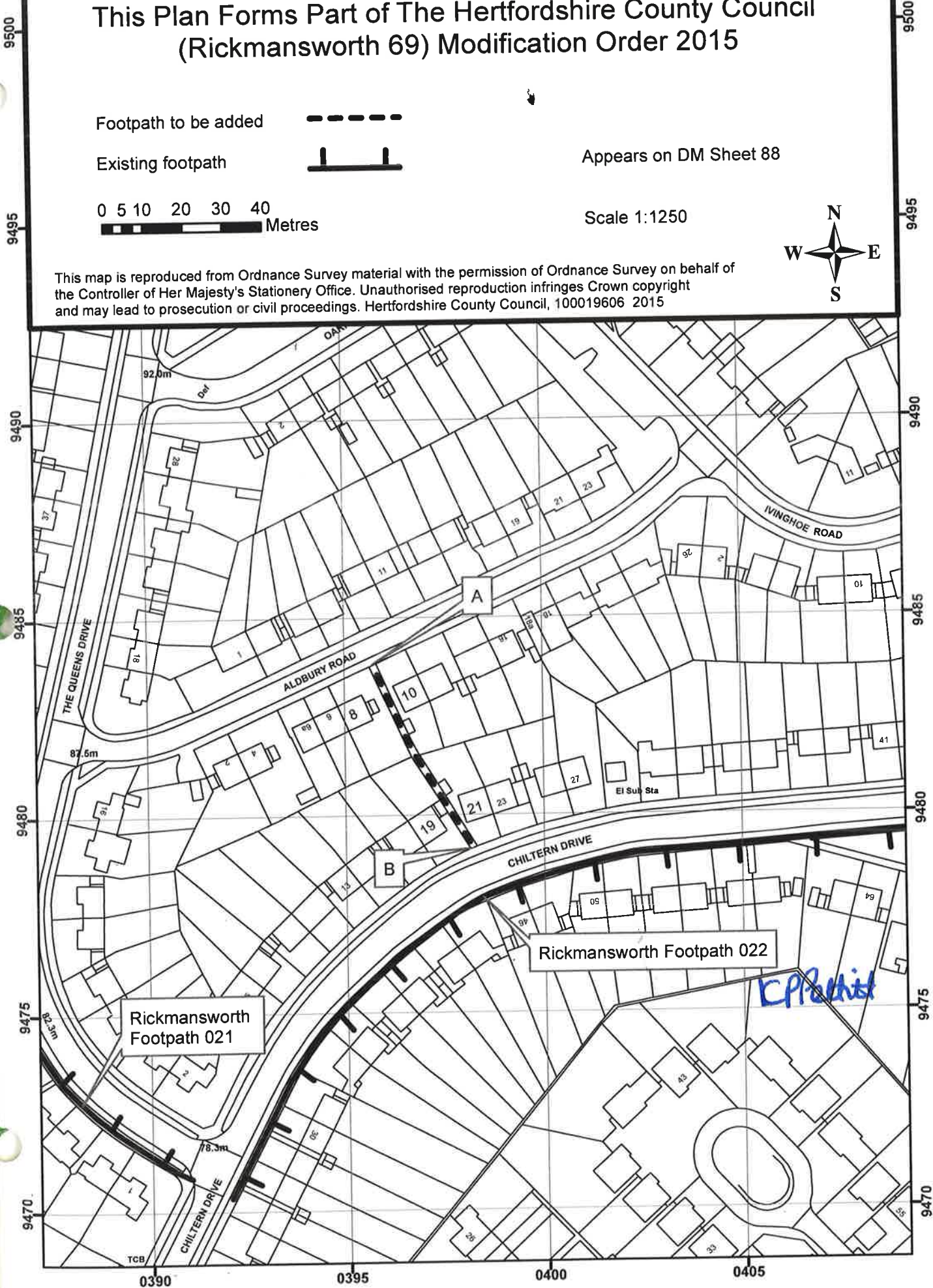
