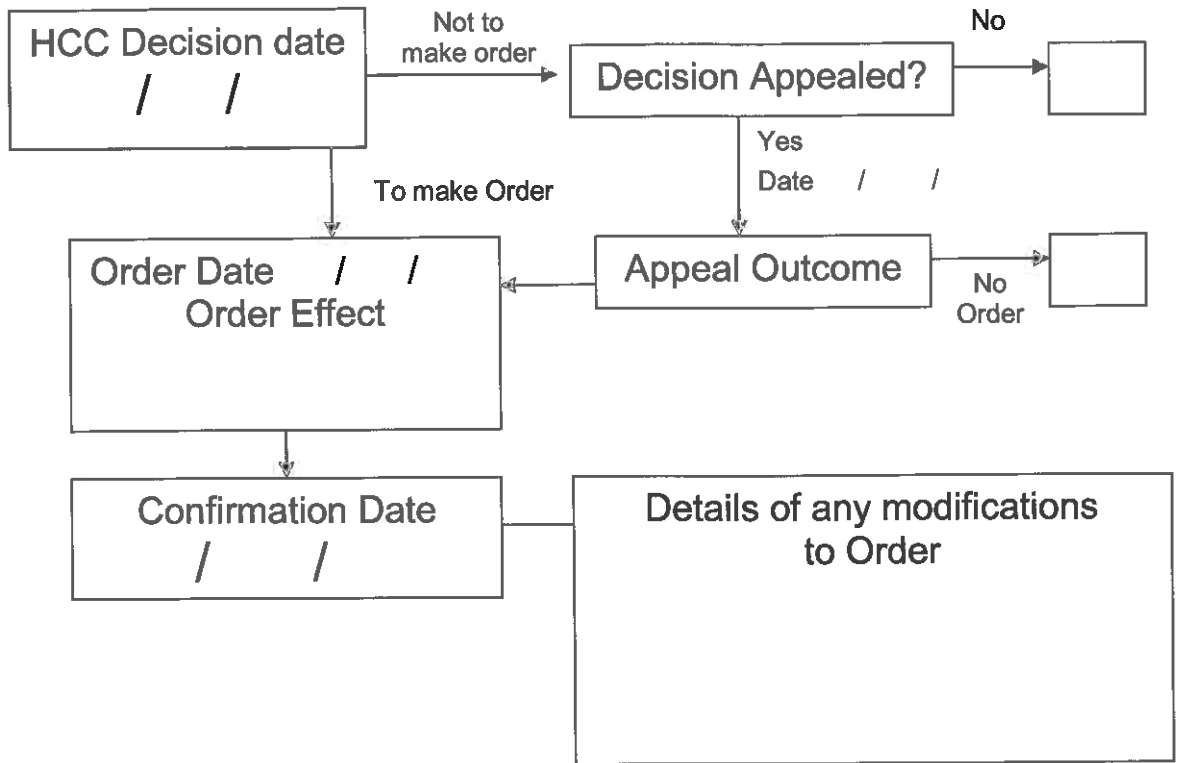

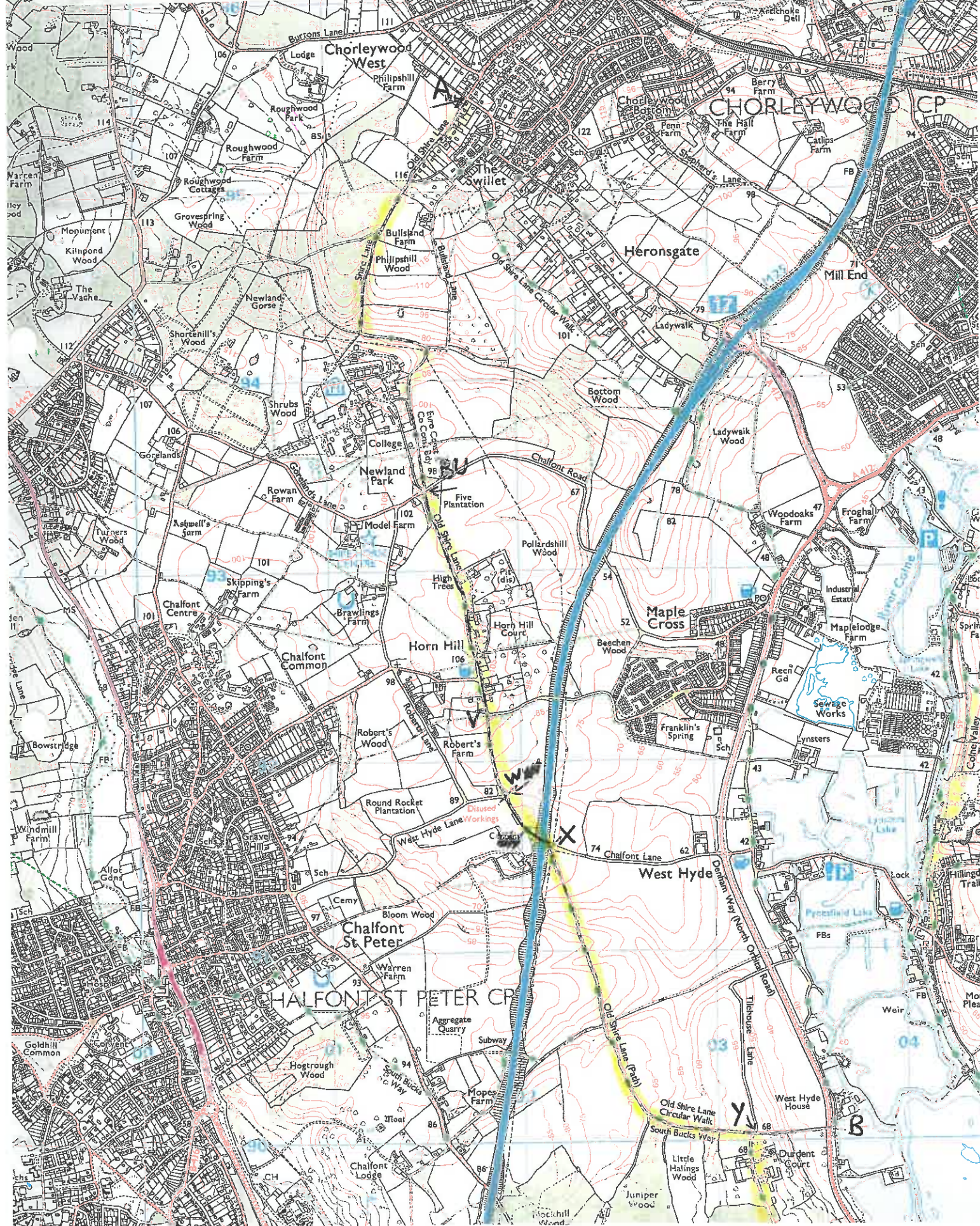

I, Dr Philip David Wadey of 12 Home Close, Corsham, Wiltshire SN13 0BE hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

- Upgrading to a restricted byway, the bridleway (part of Rickmansworth 2 BW and Chorleywood 33 BW) from Heronsgate Road (Swillett Corner, Point A) to Chalfont Road (Newlands Corner, Point U),
 - Upgrading to a byway open to all traffic, the bridleway (part of Rickmansworth 2 BW) from Chalfont Road (Point U) to Hornhill Road (Point V),
 - Upgrading to a restricted byway, the bridleway (part of Rickmansworth 2 BW) from Hornhill Road (Point V) to Hyde Lane (Point W),
 - Upgrading to a byway open to all traffic, the bridleway (part of Rickmansworth 2 BW) from Hyde Lane (Point W) to Chalfont Road (Point X),
 - Upgrading to a restricted byway, the bridleway (part of Rickmansworth 2 BW) from Chalfont Road (Point X) to Tilehouse Lane (Point Y),
 - Upgrading to a restricted byway, the bridleway (part of Rickmansworth 2 BW) from Tilehouse Lane (Point Y) to Old Uxbridge Road (Point B),
- and shown on the map accompanying this application.
