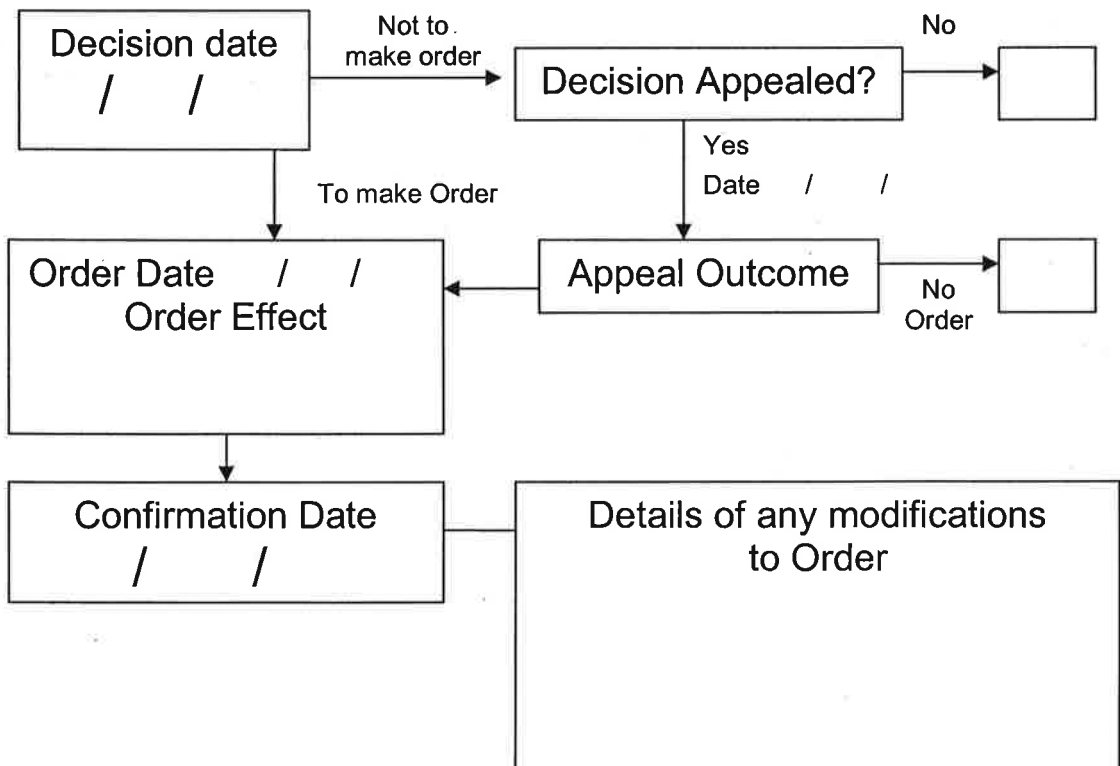

We, John Hebditch of 10 Cadogan House, Beaufort Street, Chelsea, London SW3, and Dr Philip David Wadey of Holland Farm, ALDENHAM, Hertfordshire WD2 8DJ, hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

- adding the **bridleway** from Bridleway 2 North Mymms at Grid Ref TL 2171 ~~0331~~<sup>0334</sup>, thence generally southwestwards along edge of field to the North Mymms and Ridge parish boundary at Grid Ref TL 2161 0331, thence generally southwestwards to Grid Ref TL 2140 0312, thence southwards to a junction with Bridleway 10 Ridge at Grid Ref TL 2140 0303, pens

as shown on the map accompanying this application.
