

PUBLIC PATH CREATION ORDER
HIGHWAYS ACT 1980, SECTION 26
HERTFORDSHIRE COUNTY COUNCIL

Hertfordshire County Council (Sandon 32) Creation Order 2011

This Order is made by Hertfordshire County Council ("the authority") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that, having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the path should be created.

North Hertfordshire District Council have been consulted as required by S26(3) of the 1980 Act.

BY THIS ORDER

1. There shall on the date of confirmation of this Order be a public footpath over the land at Sandon described in Part 1 of the Schedule to this Order and shown by a bold continuous line with short bars at intervals on "the Order Plan".
2. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.

SCHEDULE

PART 1
DESCRIPTION OF LAND

Footpath from the outer eastern edge of Tichney Wood at point A on the Order Plan (TL 3282 3388) continuing in a generally south westerly direction through a paddock following the outer south east edge of Tichney Wood for approximately 105 metres to point B on the Order Plan (TL 3277 3379), continuing in a generally south westerly direction through a paddock for approximately 40 metres to point C on the Order Plan (TL 3275 3376), continuing SW for approximately 5 metres to cross a culvert at point D on the Order Plan (TL 3275 3375) continuing in a generally south westerly direction for approximately 65 metres to cross a foot bridge at point E on the Order Plan (TL 3269 3371), continuing on Blagrove Common in a south easterly direction for approximately 65 metres to join Sandon 8a at point F on the Order Plan (TL 3273 3366).

Width: 3 metres
