

NOTICE OF CONFIRMATION OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

HERTFORDSHIRE COUNTY COUNCIL

Definitive Map and Statement of Public
Rights of Way in Hertfordshire

The Hertfordshire County Council (St Albans City 103) Modification Order 2014

The above named Order, made on 4th April 2014, was confirmed without modification by Hertfordshire County Council on 5th December 2014.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding to them a footpath running from a junction with Heath Farm Lane (forming part of the Registered Common called Bernard's Heath) at TL 1517 0818 generally south east to a junction with The Limes (public highway) at TL 1520 0817.

A copy of the confirmed Order may be seen free of charge at Front Reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and can be bought from Hertfordshire County Council at a cost of £2. A copy of the confirmed Order and Notice may also be seen at St Albans City and District Council, Civic Centre, St Peters Street, St Albans, AL1 3JE

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 17th December 2014, make application for the purpose of the High Court.

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(b) of the Act, namely

(b) the expiration, in relation to any way in the area to which the Map relates, of any period such that the enjoyment by the public of the way during that period raises the presumption that the way has been dedicated as a public path or restricted byway.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 1st March 2014.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan attached to the Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (St Albans City 103) Modification Order 2014.

A public Footpath commencing at a junction with Heath Farm Lane (forming part of The Registered Common called Bernard's Heath) at TL 1517 0818 (Point A on the Order Plan) running generally south east for approximately 40 metres to a junction with The Limes (public highway) at TL 1520 0817 (Point B on the Order Plan).

Width: 2 metres

Limitations: A gap of 0.92 metres at TL 1520 0817 (Point B on the Order Plan)

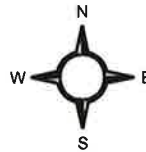

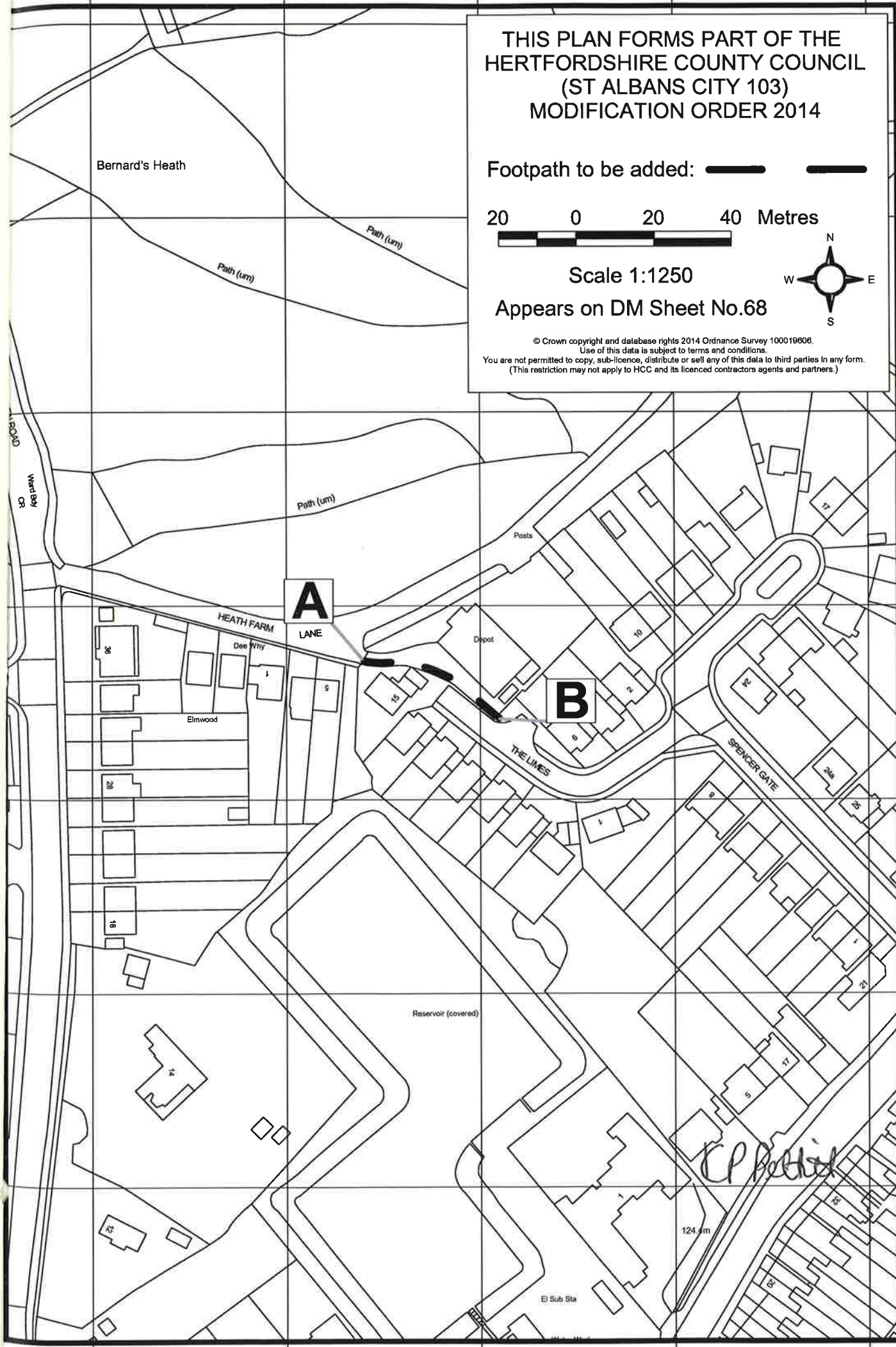
