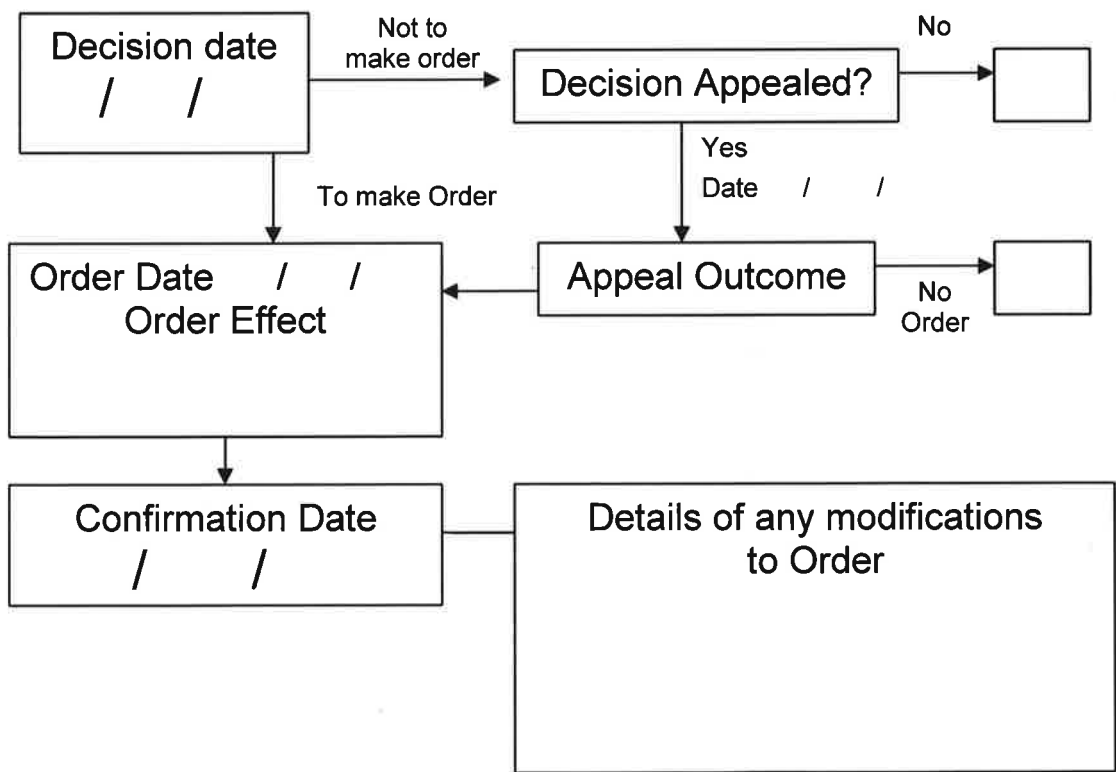

I, Dr Philip David Wadey of 12 Home Close, Corsham, Wiltshire SN13 0BE hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the area by:

Upgrading to restricted byway the bridleway (St Albans 58) from Napsbury Lane (public vehicular road) to St Albans 58 BOAT and New House Park (public vehicular road), and

Upgrading to restricted byway the footpath (St Albans 58) from London Road (public vehicular road) to St Albans 58 BOAT,

and shown on the map accompanying this application.
