EXTINGUISHMENT ORDER 2014**

On 30<sup>th</sup> May 2014, Hertfordshire County Council confirmed the above Order made under section 118 of the Highways Act 1980.

The effect of the Order as confirmed is to extinguish that part of St Paul's Walden Footpath 25 running from its junction with Horn Hill, Whitwell at TL 1826 2111 (point A on the Order Plan) in a generally easterly direction for a distance of approximately 75 metres to its junction with St Paul's Walden Footpath 28 (Buttons Lane) at TL 1834 2110 (point B on the Order Plan) as shown on the Order Plan.

A copy of the Order and the Order plan may be seen free of charge at front reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and at North Herts District Council, Gernon Road, Letchworth. Copies of the Order and plan may be bought from Hertfordshire County Council at the price of £2.

The Order comes into force as from 12<sup>th</sup> June 2014, but if any person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the grounds that it is not within the powers of the Highways Act 1980, as amended, or on the grounds that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 12<sup>th</sup> June 2014, make an application to the High Court.

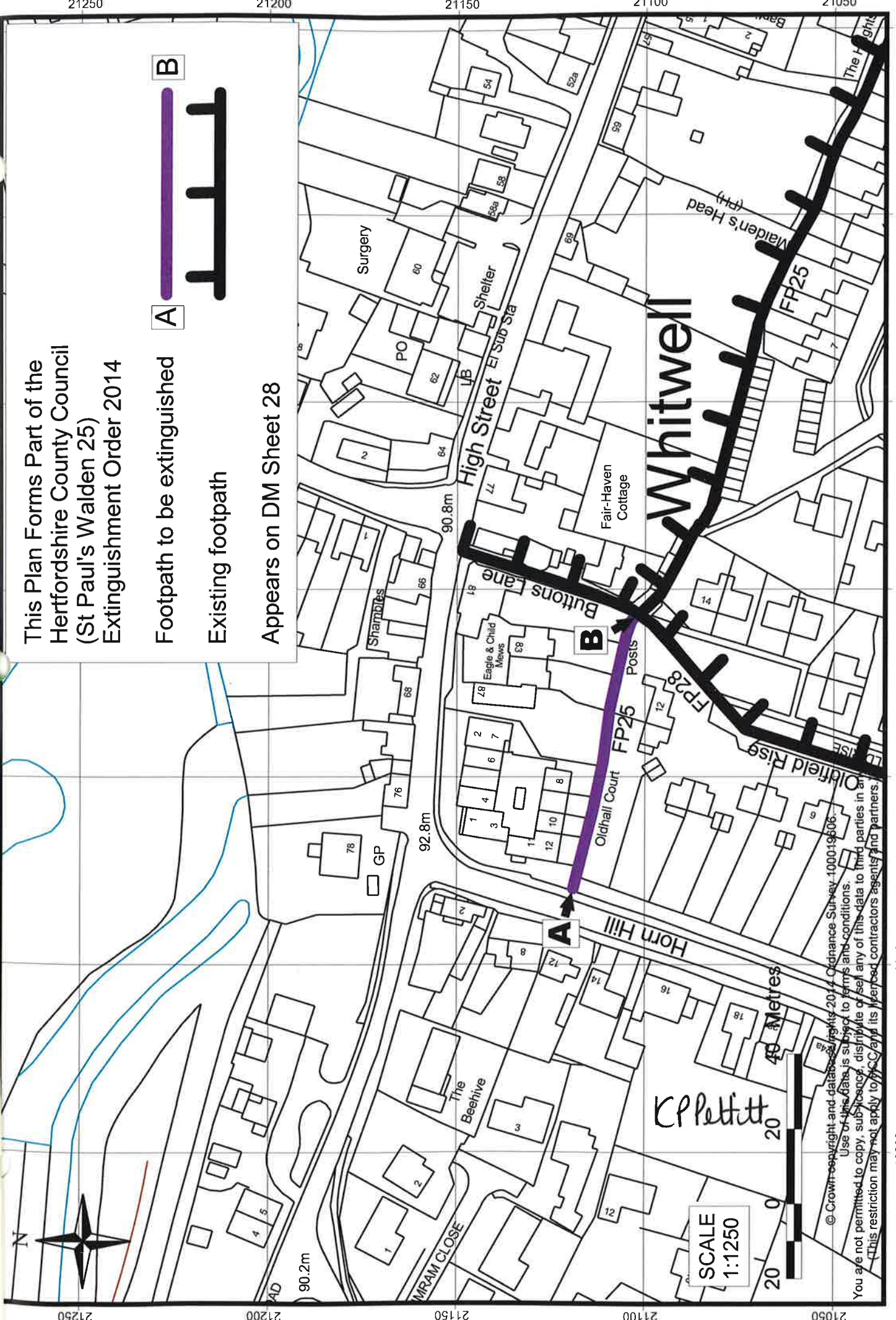
Footpath to be extinguished
