**The Hertfordshire County Council
(St Stephen 95)
Modification Order 2013**

The above named Order, made on 26th September 2013, was confirmed without modification by Hertfordshire County Council on 23rd January 2014.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding to them a footpath from Hamilton Close at TL 1312 0197 (point A on the Order Plan) continuing south west between the properties of 11 and 13 Hamilton Close for approximately 45 metres to join Rowan Close at TL 1309 0193 (point B on the Order Plan).

A copy of the confirmed Order may be seen free of charge at Front Reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and can be bought from Hertfordshire County Council at a cost of £2. A copy of the confirmed Order and Notice may also be seen at St Albans City & District Council, Civic Centre, St Peters Street, St Albans, Herts AL1 3JE

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 6th February 2014, make application for the purpose of the High Court.

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(b) of the Act, namely the expiration, in relation to any way in the area to which the Map relates, of a period such that the enjoyment by the public of the way during that period raises the presumption that the way has been dedicated as a public path or restricted byway.

The authority have consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 14th August 2013.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (St Stephen 95) Modification Order 2013.

DESCRIPTION OF PATH OR WAY TO BE ADDED

A public footpath in Bricket Wood commencing in Hamilton Close (public highway) at TL 1312 0197 (point A on the Order Plan) continuing south west between the properties of 11 and 13 Hamilton Close for approximately 45 metres to join Rowan Close (public highway) at TL 1309 0193 (point B on the Order Plan).

Width: 4.7 metres

Limitations: Staggered barriers at TL1312 0197 (point A on the Order Plan) and TL 1309 0193 (point B on the Order Plan).

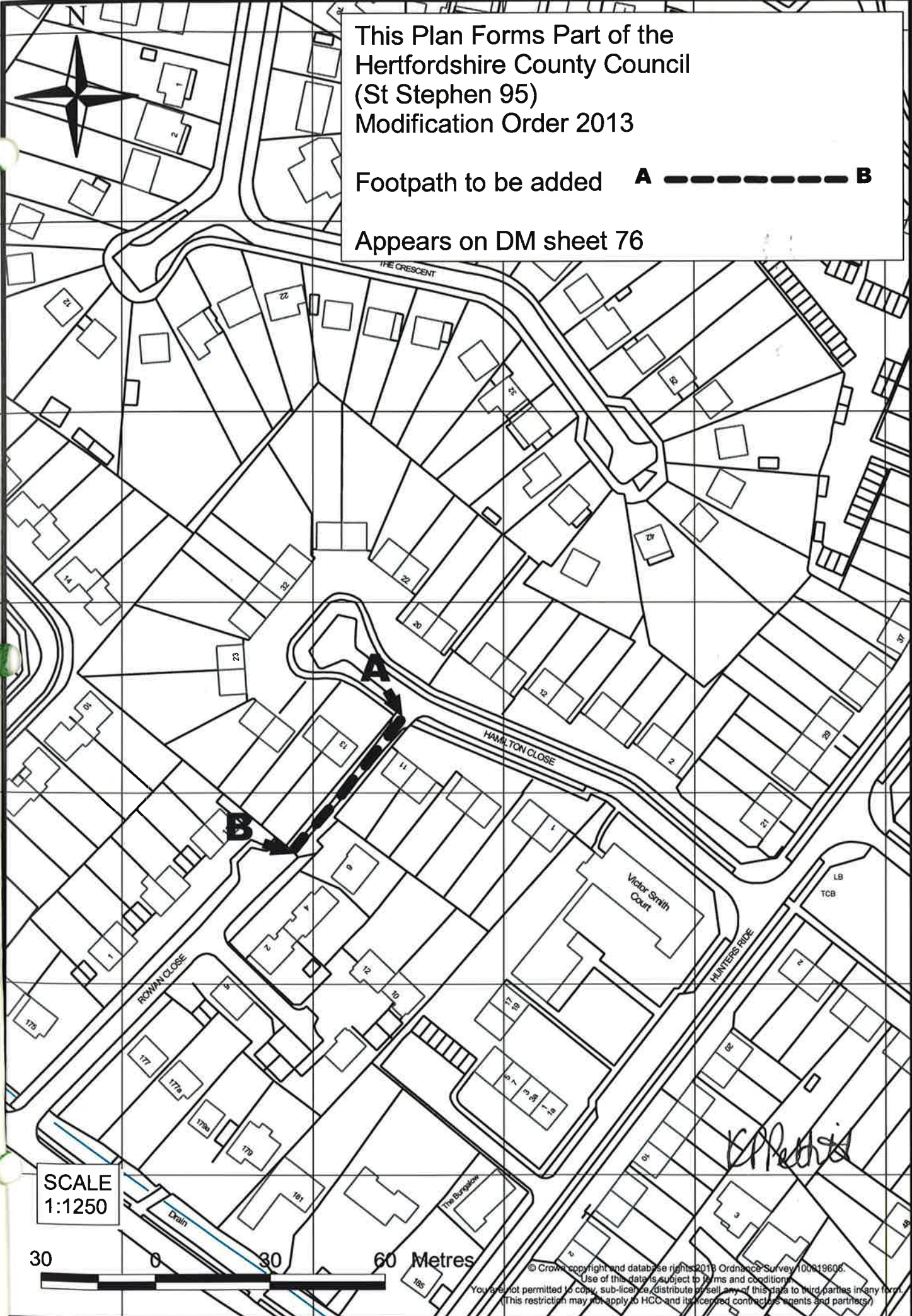
