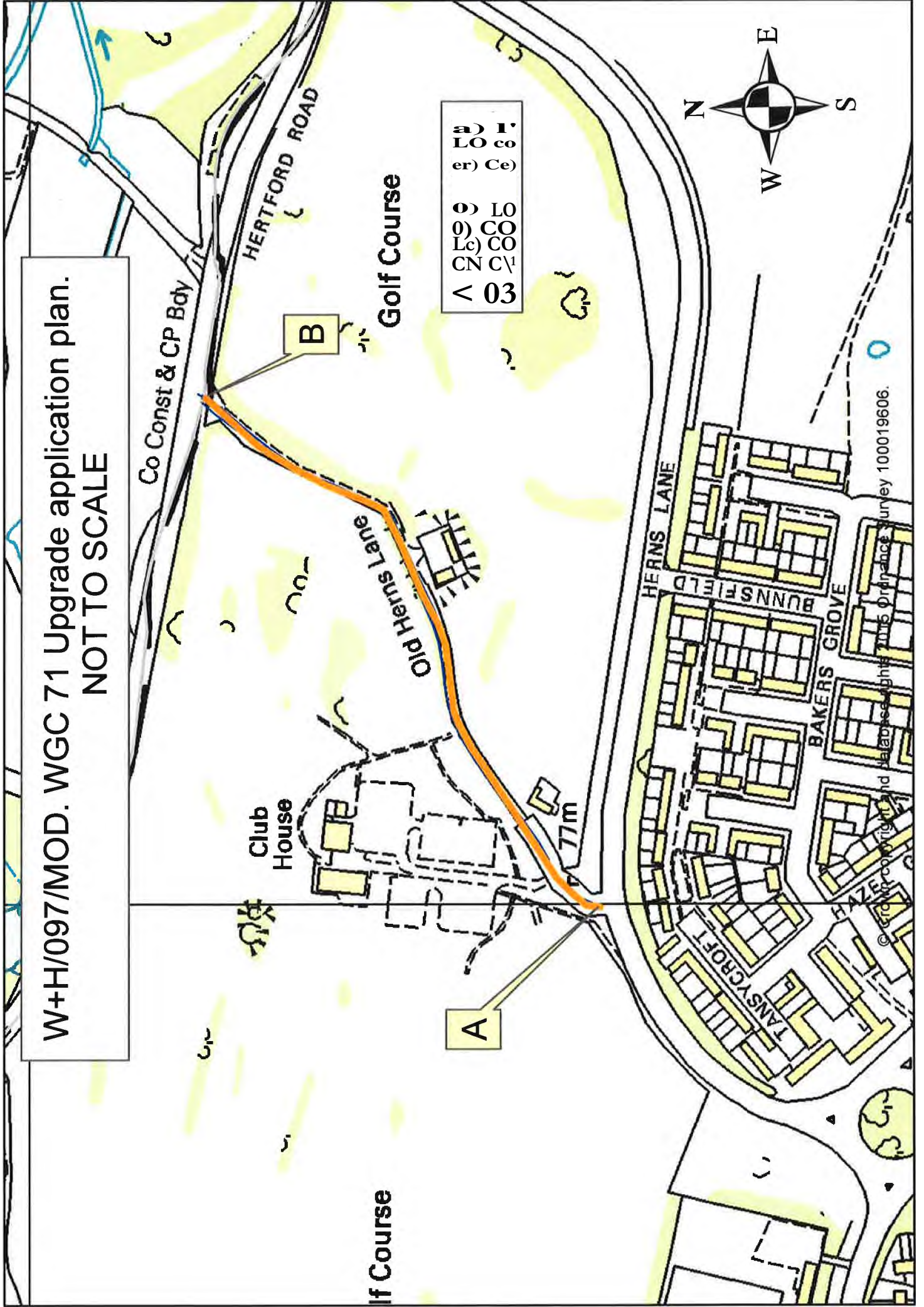

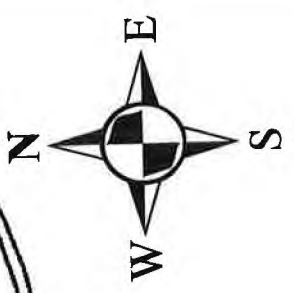

- upgrading to restricted byway the footpath (Welwyn Garden City 71 FP) from Hems Lane along the route of Old Hems Lane to a point 50metres from Hertford Road, and
- upgrading to a bridleway the footpath from a point 50metres from Hertford Road to Hertford Road,
