OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

Definitive Map and Statement of Public
Rights of Way in Hertfordshire

**The Hertfordshire County Council (Wheathampstead 54)
Modification Order 2012**

The above named Order, made on 22nd November 2012, was confirmed without modification by Hertfordshire County Council on 8th March 2013.

The effect of the Order as confirmed is to modify the Definitive Map and Statement by upgrading from a footpath to a bridleway the public right of way commencing from Mackerye End Lane, south east of Mackerye End House at TL 1569 1550 (point A on the Order Plan) then continuing along the line of FP 54, generally south-south-west then south-south-east to join Castle Rise at TL 1585 1493 (point B on the Order Plan).

A copy of the confirmed Order may be seen free of charge at Front Reception of Hertfordshire County Council, County Hall, Hertford, from 9.00 am to 4.00 pm on Monday to Friday and can be bought from Hertfordshire County Council at a cost of £2. A copy of the confirmed Order and Notice may also be seen at St Albans District Council, Civic Centre, St Peters Street, St Albans, Hertfordshire AL1 3JE.

The Order becomes operative as from the date on which it was confirmed, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 12 of Schedule 15 of the Act within 42 days from 29th May 2013, make application for the purpose of the High Court.

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(ii) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The authority have consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 20th November 2012.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Wheathampstead 54) Modification Order 2012.

DESCRIPTION OF PATH OR WAY TO BE UPGRADED

Wheathampstead Footpath 54 to be upgraded to bridleway commencing from Mackerye End Lane (public highway), south east of Mackerye End House at TL 1569 1550 (point A on the Order Plan) then continuing generally south-south-west for approximately 40 metres then south-south-east for approximately 560 metres to join Castle Rise (public highway) at TL 1585 1493 (point B on the Order Plan).
