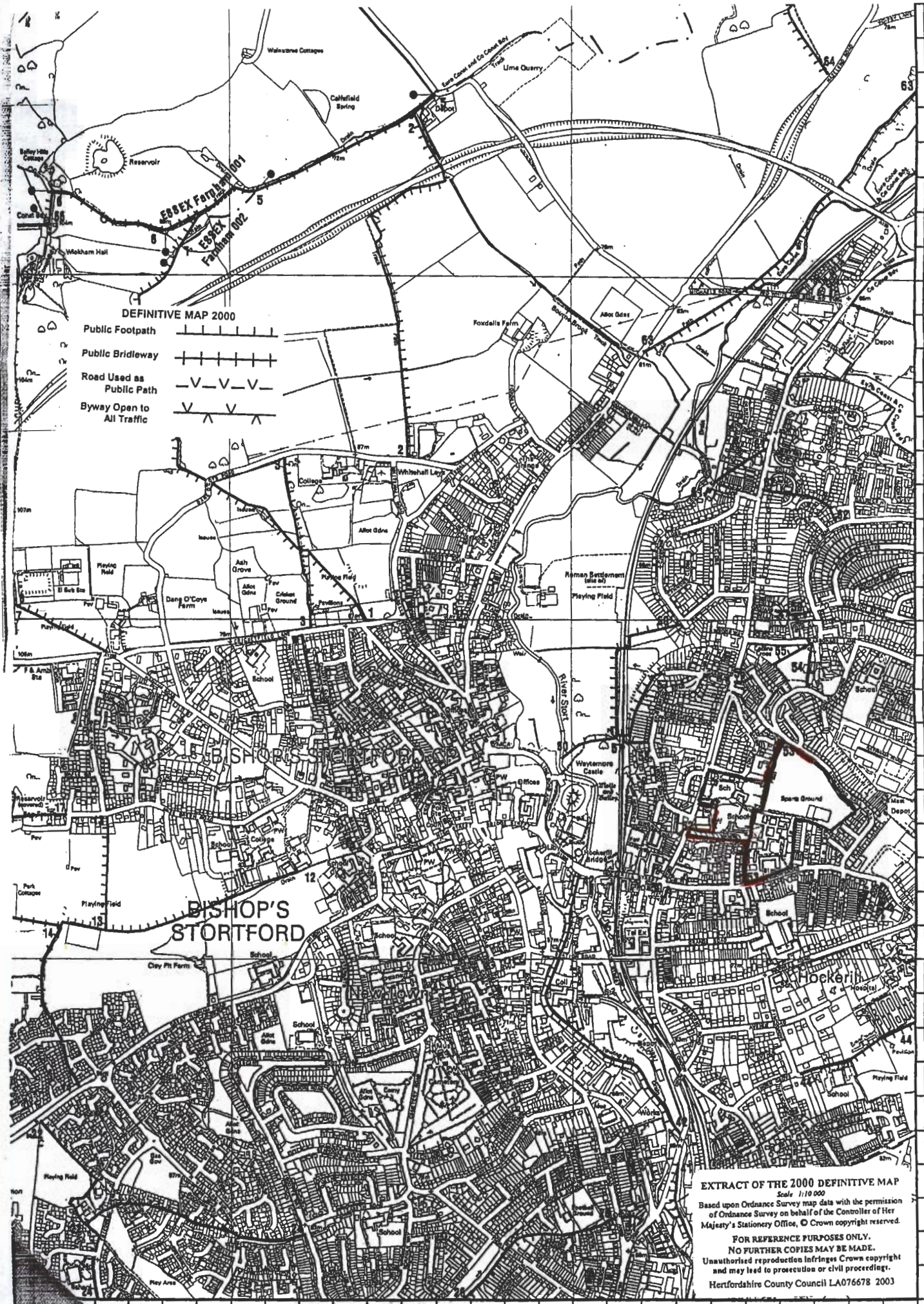

I, _____ duly authorised on behalf of the Governing Body of Hockerill Anglo-European College, **DO SOLEMNLY AND SINCERELY DECLARE** as follows:-

1. The Governing Body of Hockerill Anglo-European College has been since the 31st day of May 1996 the owner of the land known as Hockerill Anglo-European College and more particularly delineated on the plan accompanying this Declaration and thereon edged in red.
2. On the 21st day of May 2004, I on behalf of the Governing Body of Hockerill Anglo-European College, deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating the property of Hockerill Anglo-European College, by red edging, which stated that the way coloured purple on the said plan and the plan accompanying this Declaration and referred to as 53, had been dedicated as a footpath and that no other ways had been dedicated as highways over the property of Hockerill Anglo-European College.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this Declaration since the date referred to in 2. above, and at the present time the Governing Body of Hockerill Anglo-European College has no intention of dedicating any more public rights of way over the said property.
